

SAUK VALLEY COLLEGE BOARD OF TRUSTEES
SPECIAL MEETING

April 17, 1973

The Board of Sauk Valley College met in special meeting at 7:30 p.m. on April 17, 1973 for the purpose of conducting a canvass of the election held April 14, 1973. This meeting was held in the Board Room of Sauk Valley College, Rural Route #1, Dixon, Illinois and a copy of the official written notice of the meeting is attached herewith.

Call to Order:

Chairman Perkins called the meeting to order at 7:30 p.m, and the following members answered roll call:

Since this had been called to canvass the election held April 14, 1973, Mrs. Perkins instructed Robert Edison to bring all election boxes to the Board Room so the canvass could begin. Mr. Philip Ward Jr. conducted the election canvass and the following discrepancies were noted:

Precinct #15: 96 votes for Oscar Koenig listed as the total for him on the but the actual marks counted totaled to 91.

Precinct #13: The judge's certificate was not signed, but the tally list was signed by the judges. Tally sheets were not totaled and the tally list did not add up to the judge's work sheet.

Precinct #1: The total possible votes for Lyndon would have been 34 votes, but the certification sheet showed 35 votes.

Precinct #23: There was no tally sheet for this precinct. Delivered with the envelope were the affidavits of voters instead of the tally sheet. The certification of the judges was included and did agree

with the canvass sheet. Total possible votes for this precinct would have been 270 votes, but the judges certified to 281 votes. The affidavits of voters were returned to the envelope by Mr. Ward, put back in the election box and returned to the possession of Robert Edison, Dean of Business Services.

Precinct #19

Please note that four sheets of affidavit of voters were placed in the envelope by the judges with the tally sheet. It should be further noted that these four sheets were returned to the envelope by Mr. Ward, put in the election box and returned to the possession of Robert Edison.

Precinct #25: Certification of judges showed 443 ballots, 23 defective and 423 good ballots.

Precinct #10: The official certification does not show the total number of votes cast. On the judges work sheet which was signed, it shows 51 votes cast and no defective ballots.

Precinct #21: The precinct number was not shown on the tally sheet or the certification sheet, however, these two documents were identified by the name Walnut High School.

Precinct #8: 131 marks on tally sheet were counted for Dr. Gray instead of the reported figure of 130. The certification does not show the total number of ballots, the signed work sheet indicates 7 absentees and 5 spoiled or rejected ballots for a total of 215 net votes counted.

Precinct #9: Discrepancies were found in columns 80 and 110 on the tally sheet for Mrs. Swim and 224 marks were counted on the tally sheet instead of the reported 222. For Oscar Koenig, discrepancies were found in columns 25, 50 and 55 and a total of 59 marks were counted for Mr. Koenig instead of the reported 56. In column 100 for Ronald Coplan a discrepancy was found and the total marks counted for Mr. Coplan were 109 instead of the reported 108. In regard to write-in votes, Rod Wallace showed two write-in votes on the tally sheet and on the certificate, this was listed as one vote, total write-in votes should have been 3 votes.

Precinct #4: Total votes listed for Margaret Swim were 66 votes, but actual count on the tally sheet revealed 67 votes.

Precinct #12: Tally sheets were set up incorrectly in that they were set up in graph style with lines drawn to the approximate numbers and totals written in on the right-hand side. Certification does not show the number of votes for each individual, but does show a total of 54 votes cast with one defective vote.

Resolution: It was then moved and seconded that the Board adopt the attached resolution on the election with the corrections as noted above. In a roll call vote, all members voted present.

In a second roll call vote (at which time Member Coplan was requested to vote last) the following was recorded: Ayes Members DeWeerth, Kobbeman, Reigle, Reuter, Walter, Perkins, and Coplan. Nays-0. Motion carried.

Adjournment: Since there was no further business, it was moved and seconded that the Board adjourn. In a roll call vote, all voted aye. 'Motion carried.
