CANVASS OF REGULAR ELECTION HELD SATURDAY, April 13, 1974
FOR THE ELECTION OF THREE MEMBERS TO THE BOARD OF

WHEREAS the Board of Comm—College District #506, Whiteside, Lee, Ogle, Henry, and Bureau Counties of Illinois did call a regular election for the purpose of electing 3 members to the Board and

Whereas the Board has caused a proper notice to be given of said election by publishing notice thereof once in the Daily Gazette of Sterling, Illinois and once in the Dixon Evening Telegraph of Dixon, Illinois, the same being newspapers published in and having a general circulation within the territory of the district, the date of publication of such notice did specify the precincts where the election was to be held. The time of the opening and closing of the polls, and the purpose of the election, all as evidenced by an Affidavit of the publishers of said newspaper and having attached thereto newspaper clippings of such notice as so published, which said notices and affidavits are now on file with and are a part of the permanent records of the Board of said Junior College District and in words and figures are as follows on the next page:

Whereas an affidavit properly signed by each person desiring to vote at said election and sworn to before an officer authorized by law to take affidavits, such affidavits stating the name and address of the person desiring to vote, stating that each voter resides within Comm. College District #506, Whiteside, Lee, Ogle, Henry and Bureau Counties, Illinois, and is registered to vote in general elections from a residence located within said district, and further stating that such persons so desiring to vote is a qualified voter in said school district has been filed with the Secretary of the Board and an examination of such affidavits evidences the fact that each person that did vote at said election did sign such an affidavit as above referred to, a true and correct copy of the form of affidavit prepared for use at said election being as follows:
