

MINUTES OF THE SAUK VALLEY COLLEGE BOARD OF TRUSTEES ADJOURNED MEETING

April 19, 1976

The Board of Trustees of Sauk Valley College met in adjourned meeting at 7:30 p.m. on April 19, 1976 in the Board Room of Sauk Valley College, Rural Route #1, Dixon, Illinois.

Call to Order: Chairman Coplan called the meeting to order and the following members answered roll call:

Executive Session: At 7:33 p.m. it was moved by Member Reigle and seconded by Member Simmons (Gaulrapp) that the Board adjourn to executive session to discuss the possible dismissal of an employee. Motion voted and carried.

Regular Session: At 8:01 p.m. it was moved by Member Gaulrapp and seconded by Member Keefer that the Board return to regular session. Motion voted and carried.

Personnel Matters: Chairman Coplan noted that the board had listened to over 16 hours of testimony on the recommendation of President Cole to terminate the employment of Duane Paulsen, Director of the Learning Resource Center. He said as per the attached Findings of the Board of Trustees, that the Board does not concur with the recommendation for termination and directs the President to relieve Duane Paulsen of his duties as Director of the Learning Resource Center no later than June 30, 1976 and reassign him within the college as appropriate considering his qualifications and experience.

It was then moved by Member Reigle and seconded by Member Judd that the Board of Trustees approve the attached Findings as presented. In a roll call vote the following was recorded: Ayes Members Judd, Keefer, Koenig, Reigle, Simmons, Wolf and Coplan. Member Gaulrapp abstained. Motion carried.

Election Canvass: It was moved by Member Reigle and seconded by Member Wolf that the Board adopt the attached resolution on the vote canvass for the April 10, 1976 Board of Trustees election which showed the two individuals

Motion voted and carried.

Chairman Coplan expressed the appreciation of the Board of Trustees to William Judd who has served faithfully during his one-year term and who has spent many hours and traveled many miles in the performance of his trustee's duties.

The Board then welcomed Juanita Prescott and seated her as the new trustee.

Approval of Minutes:

It was moved by Member Simmons (Gaulrapp) and seconded by Member Reigle that the minutes of the March 22 meeting and the adjourned meetings of April 8, April 10, and April 13, be approved as presented. Motion voted and carried.

Temporary Chairman:

The Board then appointed George Cole to serve as temporary chairman to reorganize the Board. Dr. Cole then appointed Marilyn Vinson to serve as temporary secretary.

Call to Order:

Dr. Cole called the meeting to order and the following members answered roll call:

Nominations:

Dr. Cole announced that nominations would be received for Chairman of the Board of Trustees.

Chairman:

It was moved by Member Wolf and seconded by Member Koenig that the name of Ronald Coplan be placed in nomination for Chairman of the Board of Trustees. There was discussion on this motion. It was then moved by Member Gaulrapp and seconded by Member Prescott that nominations be closed. Motion voted and carried. A vote was then taken on the nomination of Ronald Coplan for Chairman and in a voice vote the motion carried.

Vice-Chairman:

It was moved by Member Reigle and seconded by Member Keefer that the name of Robert Wolf be placed in nomination for Vice-Chairman. It was then moved by Member Keefer and seconded by Member Gaulrapp that nominations be closed. Motion voted and carried. A vote was taken on the nomination of Robert Wolf for Vice-Chairman and all ayes were recorded. Motion carried.

Secretary:

It was moved by Member Wolf and seconded by Member Reigle that the name of Arman Gaulrapp be placed in nomination for Secretary. It was moved by Member Keefer and seconded by Member Prescott that nominations be closed. Motion voted and carried. A vote was then taken on the nomination of Arman Gaulrapp for Secretary and all ayes recorded. Motion carried.

Treasurer:

It was moved by Member Gaulrapp and seconded by Member Reigle that the Board reaffirm the appointment of Robert Edison as Treasurer of the Sauk Valley College district. Motion voted and carried.

Depositories:

It was moved by Member Reigle and seconded by Member Keefer that all banks in the college district and Harris Trust and Savings of Chicago, Illinois be appointed legal depositories for the funds of the college. Motion voted and carried.

Meetings:

It was moved by Member Gaulrapp and seconded by Member Koenig that the second and fourth Mondays of each month be designated as regular meeting dates at 7:30 p.m. except for daylight savings time when the meetings will be held at 8:00 p.m. Motion voted and carried.

Board Policies:

It was moved and seconded that all existing policies and regulations of the Board be continued until altered or amended or abolished. Motion voted and carried.

In regard to a question by Member Simmons on the policies for the student board member, President Cole noted that new policies passed by the Board during the year are collected and added to the Board Policy Manual at one time.

### FINDINGS

On Tuesday, April 13, 1976, the Board of Trustees concluded the hearing on the President's recommendation that Duane Paulsen be terminated after spending over sixteen hours hearing evidence.

The charges supporting the recommendation were:

1. Inadequate performance of duties;
2. Willful and continuous neglect of duties; and
3. Unjustifiable insubordination.

It is the consensus of the Board that the evidence is insufficient to prove charges 2 and 3 and that charge one standing alone should not be the basis for termination of employment from the college.

However, the record is replete with examples of Mr. Paulsen's conduct which indicate a lack of administrative attributes. Mr. Paulsen has shown a lack of initiative, cooperation, and responsiveness; characteristics which are imperative to serve as an administrator.

Therefore, the Board finds that President Cole's recommendation for termination is not concurred with. Further, the Board directs the President to relieve Duane Paulsen of his duties as Director of the Learning Resource Center not later than June 30, 1976, and reassign him within the college as appropriate considering his qualifications and experience.

WHEREAS THE BOARD OF COMMUNITY COLLEGE DISTRICT #506 of Lee, Whiteside, Ogle, Henry, Bureau and Carroll Counties of Illinois did call a regular election for the purpose of electing two members to the Board and

WHEREAS THE BOARD HAS caused a proper notice to be given of said election by publishing notice thereof once in the Daily Gazette of Sterling, Illinois and once in the Dixon Evening Telegraph of Dixon, Illinois, the same being newspapers published in and having a general circulation within the territory of the district, the date of publication of such notice did specify the precincts where the election was to be held, the time of the opening and closing of the polls and the purpose of the election, all as evidenced by an Affidavit of the publishers of said newspapers and having attached thereto newspaper clippings of such notice as so published, which said notices and affidavits are now on file with and are part of the permanent records of the Board of said Community College District and in words and figures are as follows: (include in official minutes the two copies of the "Certificates of Publications").

### NOTICE OF ELECTION FOR MEMBERS OF THE BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT NUMBER 506

NOTICE IS HEREBY GIVEN That on Saturday, the 10th day of April, 1976, an election will be held in and for Community College District Number 506, State of Illinois, for the purpose of electing two members to the Board of said District for the full term.

For the purpose of this election, the following precincts and polling places are hereby established:

#### PRECINCT NO. 1

Shall consist of all that part of Prophetstown-Lyndon Community Unit District Number 3, Whiteside and Henry Counties, Illinois, lying within Community College District Number 506, described as that part of the District which lies North of the Rock River.

POLLING PLACE: Junior High School, Lyndon, Illinois.

#### PRECINCT NO. 2

Shall consist of all that part of Prophetstown-Lyndon Community Unit District Number 3, Whiteside and Henry Counties, Illinois, lying within Community College District Number 506, described as that part of the District which lies South of the Rock River.

POLLING PLACE: Prophetstown City Hall, Prophetstown, Illinois.

#### PRECINCT NO. 3

Shall consist of all that part of Community Unit School District Number 5, Whiteside and Lee Counties, Illinois, lying within Community College District Number 506, located within Township 22 North, Range 6 East of the 4th P.M., Whiteside County, Illinois, commonly known as Genesee Township.

POLLING PLACE: Town Hall, Coleta, Illinois.

#### PRECINCT NO. 4

Shall consist of all that part of Community Unit School District Number 5, Whiteside and Lee Counties, Illinois, lying within Community College District Number 506, located within Townships 21 and 22 North, Range 7 East of the 4th P.M., Whiteside County, Illinois, commonly known as Sterling and Jordan Townships, which lies West of the center line of Locust Street and the center line of Route 88 as extended North and South in and from the City of Sterling, Illinois.

POLLING PLACE: Washington School, 815 West LeFevre Road, Sterling, Illinois.

#### PRECINCT NO. 5

Shall consist of all that part of Community Unit School District Number 5, Whiteside and Lee Counties, Illinois, lying within Community College District Number 506, which lies East of the center line of Locust Street and the center line of Route 88 as extended North and South in and from the City of Sterling, Illinois.

POLLING PLACE: Southeast Entryway of Sterling High School Building, 1603 Fifth Avenue, Sterling, Illinois.

#### PRECINCT NO. 6

Shall consist of all that part of Community College District Number 506 which is situated within Townships 20 and 21 North, Range 6 East of the 4th

and East of a line drawn as follows: Commencing at the North end of the Galena Avenue Bridge over Rock River and running North along the center of North Galena Avenue to an extension of the West line of Chapel Hill Memorial Park; thence North to the South line of the Dixon Country Club property; thence due East to Rock River.

POLLING PLACE: The Washington School, 703 East Morgan, Dixon, Illinois.

#### PRECINCT NO. 11

Shall consist of all that part of Dixon Unit School District Number 170, Lee and Ogle Counties, Illinois, lying within Community College District Number 506, described as: That part of the District in Ogle County, Illinois, which is located West and North of Rock River and East of the East line of Section 4 in Township 22 North, Range 9 East of the 4th P.M., commonly known as Grand Detour Township, and also that part of the District in Lee County, Illinois, in Townships 21 and 22 North, Range 9 East, commonly known as Dixon Township, and Townships 21 and 22 North, Range 10 East, commonly known as Nachusa, which lies East of Rock River and North and East of the following line: Commencing at the intersection of the East bank of Rock River with a point 20 rods North of the South line of Section 22 in Dixon Township; thence East to State Highway Route No. 2, thence South along the center of said Route No. 2 to a point 20 rods South of the center of Section 26 (said point being 20 rods South of the Hill Corner); thence East to a line  $\frac{1}{4}$  mile East of the boundary line between Sections 25 and 26 in Dixon Township, and South along this line to the South boundary line of School District 170; thence East and South to the East boundary of the school district.

POLLING PLACE: The Grand Detour School, Grand Detour, Illinois.

#### PRECINCT NO. 12

Shall consist of all that part of Dixon Unit School District Number 170, Lee and Ogle Counties, Illinois, lying within Community College District Number 506, described as: That part of the District bounded on the North by Rock River, on the West by the Illinois Central Railroad main line right-of-way, on the South by Seventh Street and on the East by a line drawn as follows: Commencing at the Southwest corner of Oakwood Cemetery; thence North to the Northwest corner of Oakwood Cemetery; thence East along the North line of the cemetery to the Northeast corner thereof; thence Northerly to the Southeast corner of Idlewild Subdivision; thence North to the Northeast corner of Idlewild Subdivision; thence West to Ravine Avenue and thence Northerly along the center line of Ravine Avenue to Rock River.

POLLING PLACE: The South Central School, 207 Fifth, Dixon, Illinois.

#### PRECINCT NO. 13

Shall consist of all that part of Dixon Unit School District Number 170, Lee and Ogle Counties, Illinois, lying within Community College District

of Seventh Street in the City of Dixon; thence Easterly along the center line of Seventh Street to an extension of the Westerly line of Oakwood Cemetery; thence Northerly along said Westerly line of Oakwood Cemetery to the Northwest corner thereof; thence Easterly along the North line of the Cemetery to the Northeast corner thereof; thence Northerly to the Southeast corner of Idlewild Subdivision; thence North to the Northeast corner of Idlewild Subdivision; thence West to Ravine Avenue and thence Northerly along the center line of Ravine Avenue to Rock River.

POLLING PLACE: The Madison School, 620 Division Street, Dixon, Illinois.

#### PRECINCT NO. 15

Shall consist of all that part of Community College District Number 506, which is situated within Tampico Community Unit District Number 4, Whiteside and Bureau Counties, Illinois.

POLLING PLACE: Tampico High School, Tampico, Illinois.

#### PRECINCT NO. 16

Shall consist of all that part of Amboy Community Unit School District Number 272, Lee County, Illinois, which is located within that portion of Townships 20 and 21 North, Range Ten East of the 4th P.M., Lee County, Illinois, commonly known as Amboy and China Townships, all within Community College District Number 506.

POLLING PLACE: Amboy City Hall, Amboy, Illinois.

#### PRECINCT NO. 17

Shall consist of all that part of Amboy Community Unit School District Number 272, Lee County, Illinois, which is located within that portion of Townships 19 and 20 North, Range Eleven East of the 4th P.M., Lee County, Illinois, commonly known as Sublette and Lee Center Townships, all within Community College District Number 506.

POLLING PLACE: Ellice Dinges Elementary School, Sublette, Illinois.

#### PRECINCT NO. 18

Shall consist of all that part of Amboy Community Unit School District Number 272, Lee County, Illinois, which is located within Township 19 North, Ranges 9 and 10 East of the 4th P.M., Lee County, Illinois, commonly known as East Grove and May Townships, all within Community College District Number 506.

POLLING PLACE: Maytown Elementary School, Maytown, Illinois.

#### PRECINCT NO. 19

Shall consist of all that part of Amboy Community Unit School District Number 272, Lee County, Illinois, which is located within Township 20 North, Range 9 East of the 4th P.M., Lee County, Illinois, commonly known as Marion Township, all within Community College District Number 506.

POLLING PLACE: Walton Elementary School, Walton, Illinois.

#### PRECINCT NO. 20

Shall consist of all that part of Amboy Community Unit School District Number 272, Lee County, Illinois, which is located within that portion of Township 21 North, Ranges 9 and 10 East of the 4th P.M., Lee County, Illinois.

School District Number 271, Lee and Ogle Counties, Illinois, lying West of County Highway No. 6, commonly known as the West Brooklyn Spur, except that part thereof lying North of the highway designated as U.S. Route 30, which is situated within Community College District Number 506.

POLLING PLACE: Public School Building of said District situated in the unincorporated area known as Lee Center in Sections 6 and 7, Township 20 North, Range 11 East of the 4th P.M., Lee County, Illinois.

Shall consist of all that part of Community College District Number 506 which is situated within Morrison Community Unit School District Number 6, Whiteside County, Illinois.

#### POLLING PLACE: Morrison High School, Morrison, Illinois.

#### PRECINCT NO. 28

Shall consist of all that part of Community College District Number 506 which is situated within Thomson Community Unit School District Number 301, Carroll County, Illinois.

POLLING PLACE: Thomson High School Cafeteria, Thomson, Illinois.

#### PRECINCT NO. 29

Shall consist of all that part of Community College District Number 506 which is situated within Ashton Community Unit School District No. 275, Lee County, Illinois.

POLLING PLACE: Ashton High School, Ashton, Illinois.

#### PRECINCT NO. 30
