MINUTES OF THE SAUK VALLEY COLLEGE BOARD OF TRUSTEES MEETING

April 11, 1977

The Board of Trustees of Sauk Valley College met in regular meeting at 7:30 p.m. on April 11, 1977 in the Board Room of Sauk Valley College, Rural Route #1, Dixon, Illinois.

Call to Order: Chairman Coplan called the meeting to order at 7:30 p.m. and the following members answered roll call:

Minutes: It was moved by Member Gaulrapp and seconded by Member Keefer that the Board approve the minutes of the March 28 meeting as presented. Motion voted and carried.

Resignation: It was moved by Member Reigle and seconded by Member Koenig that the Board accept with regret the resignation of Gilbert Meredith, Coordinator of the X-Ray Technology Program, and authorize the administration to seek a suitable replacement. Motion voted and carried.

Cooperative Agreement: It was moved by Member Gaulrapp and seconded by Member Koenig that the Board approve the attached cooperative agreement with Rock Valley College as presented. Motion voted and carried.

Donovan Case: It was moved by Member Reigle and seconded by Member Koenig that the Board adopt the attached resolution in regard to the settlement of the Donovan case. In a roll call vote all voted aye except Member Thompson who abstained. Motion carried.

Ag Land Lab: The item on the Ag Land Lab is to be discussed at the next meeting.

Questions: Under "New Business", Member Prescott asked if it would be possible for the administration to define certain terms used at the meetings and in Board communications.

President Cole said he would try and compile a list of terms and definitions for the Board. She also inquired as to the possibility of faculty representation at Board meetings. Attorney Castendyck spoke to this point.

President's Report:

Dr. Cole reported on the affirmative action committee meeting minutes and the community service annual report for which he commended James Barber for a 50% enrollment increase from the previous year.

Canvass:

It was moved by Member Reigle and seconded by Member Keefer that the Board adopt the attached resolution on the vote canvass of the April 9 Board of Trustees election which showed the individuals receiving the greatest number of votes were as follows:

Motion voted and carried.

Chairman Coplan then expressed the Board's appreciation to Arman Gaulrapp and Robert Wolf for the wisdom and judgement they have brought to the Board. Laura Thompson expressed her appreciation to these two members for their help in her learning experience as a student trustee, and also helping her to grow as a person.

Adjournment:

Since there was no further business, it was moved by Member Reigle and seconded by Member Prescott that the Sauk Valley College Board of Trustees adjourn Sine Die. Motion voted and carried.

Temporary Chairman:

The Board appointed George Cole to act as temporary chairman to reorganize the Board. Dr. Cole then appointed Marilyn Vinson to serve as temporary secretary.

Call to Order:

Dr. Cole called the meeting to order and the following members answered roll call:

Nominations: Dr. Cole noted that nominations would now be received for Chairman of the Board of Trustees.

Chairman: It was moved by Member Prescott and seconded by Member Keefer that the name of Ronald Coplan be placed in nomination for Chairman, that the nominations be closed, and that the Secretary cast a unanimous ballot for Mr. Coplan. Motion voted and carried.

Vice-Chairman: It was moved by Member Keefer and seconded by Member Prescott that the name of William Reigle be placed in nomination for Vice-Chairman of the Board, that nominations be closed, and that the Secretary cast a unanimous ballot for Mr. Reigle. Motion voted and carried.

Secretary: It was moved by Member Prescott and seconded by Member Reigle that the name of Lorna Keefer be placed in nomination for Secretary, that nominations be closed, and that the secretary cast a unanimous vote for Mrs. Keefer. Motion voted and carried.

Treasurer: It was moved by Member Prescott and seconded by Member Thompson (Keefer) that the Board reaffirm the appointment of Robert Edison as Treasurer of Sauk Valley College. Motion voted and carried.

Depositories: It was moved by Member Reigle and seconded by Member Prescott that the Board designate all the banks in the college district and Harris Trust and Savings of Chicago as legal depositories for the funds of the college. Motion voted and carried.

Meetings: It was moved by Member Reigle and seconded by Member Koenig that the Board designate the second and fourth Mondays of each month as the regular meeting dates at 7:30 p.m. except for daylight savings time when the meetings will be held at 8:00 p.m. Motion voted and carried.

Board Policies: It was moved and seconded that all existing policies and regulations of the Board be continued until altered, amended or abolished. Motion voted and carried.

Welcome: Chairman Coplan then welcomed Kay Fisher and Ann Powers to the Board and congratulated Oscar Koenig on his re-election.

Promotions and
Tenure:

It was the consensus of the Board that the items on promotions and tenure should be discussed at the next Board meeting.

Grievance:

In regard to the attached grievance, it was decided that Steps #1 and #2 be waived and it should go directly to Step #3. Since Step #3 requires a Hearing Committee, Chairman Coplan appointed the following:

Chairman Reigle is to set a date to hear this grievance and notify all parties accordingly.

Discussion:



The attached memorandum from Dr. Williams and resignation letter from Gilbert Meredith indicates that he has decided to resign his position as coordinator of the x-ray technology program.

Dr. Williams and I were aware that Mr. Meredith would probably resign several months ago. He has done an outstanding job as the coordinator of the x-ray technology program. Under his leadership, excellent relations have been developed with our sponsoring hospitals and I believe he has taken us further down the road toward the un-qualified accreditation of this program. I know he was somewhat disappointed in the conditional accreditation which was given to us by the last examining team and this is probably a factor in his decision.

RECOMMENDATION:

The President recommends that the Board accept the resignation of Gilbert Meredith effective at the termination of his current contract with regret and authorize the administration to seek a suitable replacement.

You have been a very challenging and stimulating faculty member and your leaving will be a great loss to the College.


Naturally, I accept your resignation and will recommend that the Board of Trustees act on this accordingly.

A JOINT EDUCATIONAL AGREEMENT
BETWEEN
SAUK VALLEY COLLEGE AND ROCK VALLEY COLLEGE

THIS AGREEMENT is entered into this 28th day of
March, 1977, by and between the BOARD OF TRUSTEES
OF COMMUNITY COLLEGE DISTRICT NO. 506 SAUK VALLEY COLLEGE,
hereinafter referred to as SAUK VALLEY, and the BOARD OF TRUSTEES
OF COMMUNITY COLLEGE DISTRICT NO. 511, ROCK VALLEY COLLEGE,
hereinafter referred to as ROCK VALLEY, for the expressed purpose
of providing additional educational programs to the students of
each district involved in this Agreement.

Programs included under this Agreement are:

By: SAUK VALLEY COLLEGE- *Food Preparation and Service Curriculum
Certificate and A.A.S. (all options)
Medical Laboratory Technology (A.A.S.)*

By: ROCK VALLEY COLLEGE
*Aviation Maintenance Technology; Commercial Aviation
Respiratory Therapy (A.A.S.)
Respiratory Therapy Technician Certificate*

WITNESSETH:

WHEREAS, it is the desire of the parties hereto to expand
educational services to the greatest number of students in each
district served by the parties, and

WHEREAS, the parties hereto believe this Agreement should
be one of the means of implementing the State of Illinois Master
Plan - Phase III in accomplishing a viable method of cooperation
between the Parties, hereto, and

WHEREAS, by means of this Agreement, the Parties hereto desire to share programs of each institution and thereby maximize the utilization of the finances, facilities, equipment, and personnel of each institution, and by so doing, provide educational services that might otherwise be impracticable for either of the parties individually; and

WHEREAS, the Parties hereto believe that implementation of this Agreement holds great promise for further development of higher education in Illinois:

NOW, THEREFORE, in consideration of the mutual covenants hereinafter contained, the Parties hereto agree as follows:

1. INSTITUTIONAL IDENTIFICATION

For the purposes of the Agreement, the college district sending the students to another college will be referred to as the "Sending College", and the college receiving students from another college district will be referred to as the "Receiving College."

2. TERMS OF AGREEMENT

Any educational program offered by the parties to this Agreement shall be an approved program by the Illinois Community College Board at the "Receiving" institution.

3. DURATION OF AGREEMENT

The administration of each of the Parties hereto shall confer and agree upon an educational program to be subject to the terms of this Agreement prior to the beginning of such an instructional offering, and such initial Agreement shall be in force until either party issues a letter of intent to cancel the Agreement, with such notification affirmed at least thirty (30) days prior to the termination date.

4. AMENDMENTS TO AGREEMENT

Amendments and/or revisions to this Agreement may be made at any time by mutual consent of all parties in writing. Such amendments and/or revisions shall be prepared in the form of an addendum agreement. The procedure for approval of such addenda and/or revisions shall follow the same procedure employed in securing approval by all parties in the original cooperative agreement.

5. TERMINATION OF AGREEMENT

In the event of termination, students who have entered an education program shall be allowed a maximum of ten years from the date of termination to complete the program under the terms of this Agreement.

6. CLASS SCHEDULES

Schedules of classes will be exchanged by the two schools.

7. REGISTRATION

Students shall register at the "Receiving" college and shall be considered members of that district for the terms of their enrollments. Courses taken at the "Sending" college must be part of the student's program of studies and approved by the "Receiving" college. Upon successful completion, courses approved in the student's program taken at the "Sending" college would be acceptable for transfer to the "Receiving" college for completion of the program.

8. ADDITIONAL EDUCATIONAL SERVICES

The "Receiving" college shall provide access to its Learning Resources Center and other instructional resources for students from the "Sending" college, equal to those provided for any other student at its campus.

The "Receiving" college shall also provide counseling-guidance and other services that will facilitate the learning process.

Courses, seminars, workshops and in-service programs related to any educational program bound by this Agreement may be offered within the district confines of any "Receiving" or "Sending" institution with the consent of both districts. Said programs may be carried on singly by the "Sending" or "Receiving" institution or jointly by both "Sending" and "Receiving" institutions.

9. STUDENT-RECOGNITION OF COMPLETION

The "Receiving" college shall maintain all admission records, transcripts, and issue any and all degrees or certificates to the students completing the educational program.

10. SCHOLARSHIPS AND STUDENT ACTIVITIES

The "Receiving" college shall be considered the home district for athletic eligibility and/or any other activity where the student officially represents an institution as well as for military and Illinois State Commission Scholarships.

11. RECORDS

The "Receiving" college shall maintain appropriate records for students from the "Sending" college in accordance with standard procedures while that student is in attendance in the "Receiving" institution and will provide copies of said records to the "Sending" college at the request of the student concerned.

12. PUBLICITY

Any educational program offered through this Agreement shall be duly publicized in the participating district catalog and other informative brochures consistent with institutional policy or all other similar publicity.

13. STUDENT ENROLLMENTS

For the programs covered under this Agreement, the McHenry and Rock Valley districts are considered one district.

14. IDENTIFICATION OF CONDITIONS OF AGREEMENT TO STUDENTS

It shall be the responsibility of the "Sending" college to identify the terms of this Agreement to their students going to a "Receiving" college. Said students shall be responsible for all normal operating rules and conditions of the campus he is on at any given time.

15. REIMBURSEMENT

The "Receiving" college shall be eligible to file all claims for reimbursement for any student enrolled in their classes from a "Sending" college.

16. INSURANCE

Students at the "Receiving" college shall be covered by the terms of their liability insurance while on the premises of the "Receiving" college.

17. EMERGENCIES

In the event of an emergency:

- (a) proper first aid practices should be employed by the "Receiving" college, and
- (b) next-of-kin or designated individual shall be notified.

18. TRANSPORTATION

Students shall be responsible and liable for their own transportation to and from both "Sending" and "Receiving" colleges.

19. EDUCATIONAL CHARGES FOR SERVICES RENDERED

No charge backs will be made by the "Receiving" college to the "Sending" college for students attending under the provisions of the Agreement. For the purposes of construction space support, FTE enrollment in the classes taken at the "Receiving" institution shall be reported by the "Receiving" institution.

20. FEEDBACK TO SENDING INSTITUTION

The receiving institution will provide to the sending institution appropriate statistical data regarding enrollments from the institution approximately each year.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement in two (2) counterparts, each of which shall be deemed an original, as of the date and year first above written.

RESOLUTION AUTHORIZING SETTLEMENT
OF THE DONOVAN CASE

BE IT AND IT HEREBY IS RESOLVED, that settlement of the case of DONOVAN CONSTRUCTION COMPANY vs. ILLINOIS BUILDING AUTHORITY, SAUK VALLEY COLLEGE, et al, Case No. 72-C-1237, in the United States Federal District Court for the Northern District of Illinois, Eastern Division, be and the same is hereby approved on the following terms:

1. CNA, as insurer for the two architects, will pay DONOVAN \$100,000 in cash.
2. DONOVAN will dismiss its entire suit.
3. The ILLINOIS BUILDING AUTHORITY, as part of the consideration in settling the case, will intercede and exert its best efforts to induce all appropriate agencies, including the CAPITAL DEVELOPMENT BOARD and the ILLINOIS GENERAL ASSEMBLY to appropriate \$100,000 to effectuate needed repairs at the College.
4. The College will undertake an independent expenditure of \$100,000, using its own personnel where appropriate and necessary to effectuate similar repairs.
5. All parties will exchange mutual releases and acquittance papers.
6. The ILLINOIS BUILDING AUTHORITY and SAUK VALLEY COLLEGE will dismiss their counterclaim.
7. There will be no necessity for the COLLEGE or the IBA to pay DONOVAN any sum whatsoever, and DONOVAN, by acquittance papers, will relinquish any claim to any retainage.
8. Dismissal of the complaint and counterclaim on the foregoing basis is ratified and counsel for the COLLEGE is authorized to sign an appropriate Stipulation for Dismissal.

CANVASS OF REGULAR ELECTION HELD SATURDAY, APRIL 9, 1977, FOR THE ELECTION OF THREE MEMBERS TO THE BOARD OF COMMUNITY COLLEGE DISTRICT #506, WHITESIDE, LEE, OGLE, HENRY, CARROLL AND BUREAU COUNTIES, ILLINOIS AND DECLARATION OF SAID ELECTION.

WHEREAS THE BOARD OF COMMUNITY COLLEGE DISTRICT #506 of Lee, Whiteside, Ogle, Henry, Bureau and Carroll Counties of Illinois did call a regular election for the purpose of electing 3 members to the Board and

WHEREAS THE BOARD HAS caused a proper notice to be given of said election by publishing notice thereof once in the Daily Gazette of Sterling, Illinois and once in the Dixon Evening Telegraph of Dixon, Illinois, the same being newspapers published in and having a general circulation within the territory of the district, the date of publication of such notice did specify the precincts where the election was to be held, the time of the opening and closing of the polls and the purpose of the election, all as evidenced by an Affidavit of the publishers of said newspapers and having attached thereto newspaper clippings of such notice as so published, which said notices and affidavits are now on file with and are part of the permanent records of the Board of said Community College District and in words and figures are as per attached.

WHEREAS, AT SAID ELECTION the names of the candidates were submitted upon proper ballots a sample of which is attached to the official minutes,

WHEREAS, AN AFFIDAVIT PROPERLY signed by each person desiring to vote at said election and sworn to before an officer authorized by law to take affidavits, such affidavits stating the name and address of the person desiring to vote, stating that each voter resides within Community College District #506 of Lee, Whiteside, Ogle, Henry, Bureau and Carroll Counties, Illinois and is registered to vote in general elections from a residence located within said district, and further stating that such persons so desiring to vote is a qualified voter in said school district has been filed with the Secretary of the Board and an examination of such affidavits evidences the fact that each person that did vote at said election as above referred to, a true and correct copy of the form of affidavit prepared for use at said election being as attached herein.

WHEREAS the RETURNS of SAID election have been submitted to the Board and the Board had duly canvassed the returns of the ballots cast at said election as per the attached canvass.

THEREFORE, THE BOARD OF Community College District #506, Counties of Lee, Whiteside, Ogle, Henry, Bureau, and Carroll, State of Illinois, as a canvassing Board finds as follows:

That proper notice of and proper ballots were used at the election held in and for the territory known as Community College District #506, Counties of Lee, Whiteside, Ogle Henry, Bureau and Carroll on the 9th day of April, 1977 and that all persons voting at said election did sign a proper affidavit indicating the affiants to be qualified voters of the territory of said district, all as referred hereinabove in the preamble of this document.

That the total number of affidavits of voters signed and the total number of voters voting at said election were 6,448.

That the details of the votes cast for the respective candidates referendum were as listed on the preceding page, and that the individuals receiving the greatest number of votes, and the votes received by said individuals were as follows:

RE: AGENDA ITEM #F-1 - FACULTY ASSOCIATION GRIEVANCE

On Wednesday, April 6, I was approached by five faculty members who had requested a meeting to discuss recent Board action concerning the establishing of a flat \$300 rate for summer school payment.

Among this group were two members of the Sauk Valley College Faculty Association Grievance Committee as well as chief negotiator. This group indicated that they were having this meeting with me with the knowledge and support of the President of the SVC Faculty Association, Don Burton, although he was not present at the meeting. I was presented with a grievance. It was the wish of this group that Steps #1 and #2 of the grievance procedure be bypassed or expedited. Also present at this meeting was James Strickland, assistant dean of career education.

In this meeting I attempted to explain the rationale for the recommendation I had made to the Board, which was backed-up by attached materials, reducing summer school pay to \$300 per semester hour and also indicated that it was the Board's legal position that this item has not been successfully negotiated by the Faculty Association in an effort to enter specific pay rates into the contract language and that the Board had preserved its right to set salaries.

It was further our opinion that this was not a matter subject to grievance or arbitration. Mr. Gates indicated that this was an item of disagreement but that it was his opinion that it was not proper for the Association to go to court until they had at least exhausted the grievance procedure. In my opinion, it would be in the best interest of the college and the Faculty Association to waive Steps #1 and #2 and go directly to Step #3. You will recall that Step #3 requires that the Board of Trustees' Grievance Hearing Committee, consisting of two Board Members, the President and a Dean, hear the grievance. I would suggest that members included on the committee be myself, Dr. Williams, Ron Coplan and Lorna Keefer. In my opinion, this committee should be charged with the responsibility of meeting with the Faculty Association Grievance Committee sometime after our Board meeting of April 11 and before our meeting of April 25. I further suggest that in concert with the college attorney we prepare a response indicating that we do not feel this matter is subject to the grievance procedure or arbitration.

This I feel, would require that the issue be settled in court. I realize that I am not an attorney, but this seems like a straightforward way to bring resolution to this issue as quickly as possible and clear the decks for the more detailed bargaining which will resume in May.

Subject of Negotiations: "The Association and the Board agree that negotiations in good faith, will encompass only the following items:....(d) Related economic conditions of employment consisting of:....(9) Summer School Contracts and Compensation" (page 6, line 21), and

Whereas the past precedent has established the formula for determining the summer school compensation at the rate of 1/36 of the individual's salary contract amount, and

Whereas the President of the Board of Community College District No. 506 did, in his verbal discussions during the contract negotiating process, infer that he foresaw no changes in the summer school compensation practices,

Therefore, on behalf of myself and all other Sauk Valley College Faculty Association members, I grieve the action taken by the Board of the College, on March 28, 1977, of Unilaterally and without negotiating changing the summer school compensation referred to in the current contract, in Article II, page 6, line 21, and in all other portions of the current contract related to this issue.

I respectfully request that the summer school compensation amounts be returned to the amounts prescribed by the formula established by the precedent of prior years and each faculty member be paid accordingly.

There is apparently some confusion regarding the signing of summer school contracts. I have informed my secretary, after discussion with the Board Chairman, to accept only those contracts which are properly signed. Some faculty have chosen to write statements upon the contracts and these were given back to the faculty person as being unacceptable.

It is apparent to me that the Faculty Association will probably test in court or through the grievance process, the legality of Board action concerning the fixing of rates of pay for summer school. It would seem appropriate that should an arbitrator or a judge rule that the action taken by the Board was illegal, that the higher rate of pay would be in order for the summer school assignment. As President, however, I would like to be assured that when an individual signs his individual contract he is indicating his intention to teach the class or classes assigned to him for summer school at the described rate of pay pending a decision by an authority higher than the Board.

It is also reasonable that this type of decision or ruling would not be forthcoming until after summer school has started. To avoid confusion, I would suggest that faculty members turn in their contracts with the appropriate signature and by this letter I recognize the fact that the Association intends to attempt, through the procedures that are available, to have the \$300 per semester hour rate of pay either amended or reversed.

To facilitate the signing of contracts, we will extend the deadline date to Monday, April 11, 1977, at 5 p.m.

Re: Establishment of Summer School Pay Rates

Dear Mr. Coplan:

You have inquired as to whether or not the Board of Trustees of Sauk Valley College may unilaterally establish a new Summer School Pay Schedule. In our opinion, it may do so.

Nothing in the present contractual agreement between the Board and the Sauk Valley College Faculty Association deals specifically with the rate of pay for summer school. Article XII, which deals with professional compensation, makes absolutely no mention of the subject.

The Faculty Association has alleged that the contract provides that the Board will negotiate "Summer School Contracts and Compensation". We do not believe that such is the case. At Page 6 of the present contract appears the statement, "The Association and the Board agree that negotiations in good faith, will encompass only the following items:" (emphasis ours) There follows a list of items. This list limits the subjects which may be negotiated but does not require agreement on any particular item. This is a limiting provision rather than a mandatory directive.

The Public Community College Act provides that the Board of Community College Districts shall have the duties enumerated in Sections 3-22 through 3-29. Among the specific provisions is the duty "to make appointments and fix the salaries of a Chief Administrative Officer, who shall be the Executive Officer of the Board, other administrative personnel and all teachers." (emphasis ours)

Since there appears to be no limitation on the Board's responsibility, we believe it may proceed to make such adjustments as it deems necessary or appropriate.

'Teachers have an edge over private sector folk'

LAS VEGAS, Nev. — A decade ago some teachers gave this as one reason for wanting collective bargaining with school boards: to end their second-class citizenship. Since workers in the private sector had the right to bargain for higher salaries, improved fringe benefits, and better working conditions, so the argument went, these teachers believed, they were entitled to equity.

But last week Myron Lieberman, a nationally-known expert on teachers' collective bargaining and education professor at the University of Southern California, said that teachers now have achieved more than equity. They are running well ahead of private sector unionized employees in a number of subtle, but crucial, areas, he told a session of the American Association of School Administrators convention.

Teachers have become increasingly active in campaigning for political candidates at all levels, beginning with their local school board members on up to the President of the United States.

When teachers play a key role in supporting school board candidates, they are trying to select their own bosses. And that, Lieberman said, is a benefit which unions in the private sector hardly enjoy. School board members, of course, ultimately decide teachers' pay boosts and other benefits.

In the last several years teachers across the nation have endorsed and campaigned for candidates for governor and state legislatures. Private sector employees do have equal opportunity to elect their state officials.

However, Lieberman emphasized that governors and legislators, who are rarely in a position to affect the outcome of private sector bargaining, can become deeply involved in teachers' bargaining — through the amount of state aid approved and available for negotiations.

"The governor typically is the most important single individual in the annual aid to education controversy," Lieberman said. Since states provide almost half of public school revenue, the role of the government is obviously more important to teachers than to workers in factories or on farms.

Although Lieberman did not mention the role of a mayor, even the most casual observer of Chicago's educational scene can see a mayoralty connection in the latest strike threat of Robert M. Healey, Chicago Teachers Union president.

Healey is rattling the sabres over a proposal from School Supt. Joseph P. Hannan that the school year may be shortened three days because of the budget crunch. Healey has tentatively scheduled a union vote on a strike three weeks before the mayoral primary, while concurrently appealing to Mayor Bilandic for help.

And that leads to another point which Lieberman makes. Public employers have less incentive than private employers to resist union demands. If private sector management makes concessions impairing profits, management is immediately accountable to a board of directors.

But the school system's directors, the board of education, does not have this accountability. Indeed in Chicago, there is no accountability. The mayor appoints the board and the teachers union may try to persuade the mayor to bring pressure on the board to give the teachers what they want.

Another big advantage for teachers, Lieberman said, is that they know their employers' financial situation. "The public employer," he explained, "is at a tactical disadvantage in that the relevant financial data are readily available to the public employee union. Indeed, it is not surprising to be confronted by teacher union representatives more knowledgeable about the district budget than the administrators."

Teachers can study every line in the school budget and find waste.

Another difference is that school boards cannot move. Industry can relocate to another area to avoid unionization or union demands. The threat of doing so helps to moderate union demands, Lieberman said. "On the other hand," he continued, "you cannot move the schools of Las Vegas to Mexico, or even to Reno, in order to avoid excessive demands by teacher unions in Las Vegas."

The annual recommendations for tenure, promotions and extra increments were made by the appropriate Deans to me within the traditional time frame. Several questions have been raised by faculty members about when action will be taken on these recommendations.

The following lists indicates those individuals who are eligible for tenure, along with those individuals recommended for promotions and extra increments. We also have one individual who is being recommended for non-contract renewal.

I would suggest that all of these personnel matters be dealt with in the near future. The primary question is whether the outgoing Board would like to make these decisions or whether they would like to defer it to the time when the new Board is seated. There has been voluminous material prepared by the Deans to justify their recommendations.

I would suggest that this item be discussed at the next Board meeting and that if the outgoing Board feels they would like to make these decisions the reproduced material can be provided to them at that meeting and decisions can be made by the Board in our meeting of April 18.

If, on the other hand, it is felt that the decision should be deferred I will put it on a later agenda and give the new Board members adequate time to review the background materials so that they might make this decision.

Following is a summary of the President's recommendations concerning personnel items mentioned in the memorandum mailed to you last Wednesday, April 6.

1) It is first of all my recommendation that all of those individuals eligible for tenure be given tenure. The Deans have provided adequate background material to me to indicate that all of these individuals have distinguished themselves both in terms of academic preparation and in terms of performance at Sauk Valley College since their arrival.

If any Board members have further questions I would be more than happy to provide this background material.

RECOMMENDATION:

The President recommends that the Board grant tenure to the following individuals effective July 1, 1977:

2) The Dean (Dr. Williams) and the Director of Public Safety (Mr. Crouse) have provided adequate background material to support the recommendation that the contract of Larry Geldean not be renewed for the 1977-78 academic year. I have carefully reviewed this material and I concur with the recommendation. Normally this matter would not be acted upon by the Board. I feel, however, that because of the recent Board election it might be appropriate for the Board to offer a motion of support for this administration recommendation.

RECOMMENDATION:

The President recommends that the Board approve the non-renewal of the contract for Larry Geldean for the 1977-78 academic year.

3) The opportunity to provide a recommendation for extra increment for those faculty members who have distinguished themselves through extraordinary service and who are not at this time eligible for promotion, is provided in the contract. In the past, however, we have not given extra increments. It is my recommendation that we not provide extra salary increments to the two faculty members the Deans have recommended for increments, David Lovekin and Edward Beatty. I would, however, like the Board to know that a special commendation should be placed in their file for the outstanding contributions each of these individuals has made during the past academic year.

Very specifically, David Lovekin was able, through working with Dick Hamlin, to secure a \$12,000 grant to the institution for the implementation of our conference on "Human Values and the Technological Society".

Edward Beatty should be commended for his innovative and cooperative leadership in the area of off-campus communication instruction. Through his leadership we were able to provide quality educational experiences to those individuals who are permanent residents in area nursing homes.

4) In the following recommendation for promotions I have indicated the current rank, step and salary of each individual being recommended for promotion. I have also indicated the rank and step to which they are being recommended for promotion. If it is the decision of the Board to provide each faculty member with a normal annual increment, then each of these individuals would receive that increment and any additional amount of increase provided through the bargaining process. It is consistent with past practice within the college to provide an individual who is promoted with an extra increment.

To avoid the misunderstandings which normally occur in this process, I would like to make myself painfully clear by using the following example. Mr. Gates is promoted from instructor, Step XI, to assistant professor, Step VII. If all faculty members are given a normal increase in the 1977-78 year, he would move automatically to Step VIII. If the pay scale is renegotiated, he would receive the normal annual increment plus an increment for promotion.

RECOMMENDATION:

The President recommends that the Board approve the promotions shown on the attached sheet, effective with the 1977-78 academic year.
