RESOLUTION APPOINTING ALTERNATE JUDGES

WHEREAS, a special election has been called for Thursday, the 10th day of May, 1979, in and for Community College District Number 506, Counties of Whiteside, Lee, Ogle, Henry, Bureau and Carroll, State of Illinois, at which election shall be submitted to the legal voters of said Community College District Number 506, propositions of whether or not the maximum annual tax rate for educational purposes and for building purposes of the District be increased, and

WHEREAS, the Board has heretofore appointed Judges to serve the precincts at said special election, and

WHEREAS, 27 Judges heretofore appointed have indicated that they are now unable to serve on election day, and it is necessary to appoint replacements in order to conduct such election, and

WHEREAS, MARILYN VINSON, the designated representative of LORNA KEEFER, Secretary of the Board of Trustees, made a proper search for qualified electors residing within all precincts to serve as Judges within their precincts, but was unable to locate sufficient such individuals to serve in Precinct 5, and said MARILYN VINSON has filed an affidavit to this effect with the Board of Trustees, a copy of which affidavit is attached to this resolution, and

WHEREAS, the Board of Trustees of said Community College District Number 506 finds that, other than the Judges identified, there is no Judge available for Precinct 5 from among the qualified electors residing in said precinct, and that in order to conduct the election it is necessary to appoint a qualified alternative Judge from outside the precinct pursuant to the authority contained in Ill. Rev. Stats., Chap. 122, Sec. 103-7.8, and

WHEREAS, electors have been found who are qualified and willing to serve as Judges to replace all other individuals previously appointed, but who have expressed inability to serve,

NOW, THEREFORE, BE IT RESOLVED that the individuals named in the sheet attached hereto and made a part hereof are appointed to serve as replacements for the individuals named to serve in the precincts shown opposite their respective names.

BE IT FURTHER RESOLVED that LILLIAN LANGLEY, a qualified elector not a resident of Precinct 5, be appointed to serve in Precinct 5 as Election Judge.

BE IT FURTHER RESOLVED that said Judges be paid in accordance with the schedule established for their respective school district in accordance with the program of compensation heretofore adopted by the Board.

I, MARILYN VINSON, being first duly sworn, on oath state:

1. That I am the duly authorized representative of LORNA KEEFER, Secretary of the Board of Trustees of Sauk Valley College, and as such, I have been advised that twenty-two of the Judges heretofore appointed by the Board of Trustees to serve at the special election called for the 10th day of May, 1979, are unable to serve.

2. That upon receiving this information, I contacted the representatives of the respective school districts from which the Judges were selected, as well as other Judges who were appointed, and I obtained the names of additional electors residing within the respective precincts who are qualified to serve as Judges.

3. That I contacted each of the individuals selected for alternative Judges and was able to secure replacements for individuals who resided within the respective precincts, with the exception of HOLLY EBERSOLE at Precinct No. 5.

4. That I made numerous phone calls to representatives of various school districts, other Judges, members of the community, and individuals who served as Judges in previous years.

5. That despite my search, I was unable to find individuals to serve in Precinct 5 and who reside within said Precinct.

6. That despite my search, I know of no qualified electors residing within the aforesaid Precinct 5 who are willing to serve as Judges of the special election to be held on May 10, 1979.

7. That after a diligent search I was able to locate one individual who is a qualified elector of the District, an experienced Judge, and willing to serve as Judge outside of her respective Precinct.

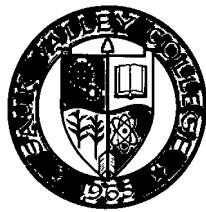
8. That the name of the individual who agreed to serve in the Precinct in which she would serve is as follows: LILLIAN LANGLEY, Precinct No. 5.
