The Board of Trustees of Sauk Valley College met in regular meeting at 8:00 p.m. on October 22, 1979, in the Board Room of Sauk Valley College, Rural Route #1, Dixon, Illinois.

Call to Order: Chairman Reigle called the meeting to order at 8:00 p.m. and the following members answered roll call:

Minutes: It was moved by Member Keefer and seconded by Member Prescott that the Board approve the minutes of the October 9 meeting as presented. Motion voted and carried.

Treasurer's Report: It was moved by Member Prescott and seconded by Member Koenig that the Board approve the Treasurer's Report as presented. In a roll call vote, all voted aye. Motion carried.

Bills Payable: It was moved by Member Keefer and seconded by Member Prescott that the Board approve the bills in the following amounts:

Audit: A copy of the 1978-79 audit was presented to the Board from Dean Edison for their study and action at the next meeting.

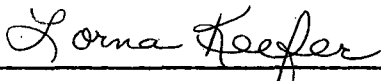

Golden Age Tuition Pass:	A brief discussion was held on the Golden Age Tuition Pass. The Board members are to study this waiver and submit any questions they might have on this.
Board Policy Manual:	It was the consensus of the Board that the administration and the Board members should study the 100 section of the Board Policy Manual. Suggested revisions, questions, or changes, should be submitted to the President's office before the meeting so that they can be duplicated.
Plumtree Ski Agreement:	It was moved by Member Koenig and seconded by Member Fisher that the Board approve the attached arrangement with the Plumtree Ski School for Sauk Valley students. In a roll call vote, all voted aye. Motion carried.

RE: Compact Agreement for Associate in Arts and Associate in Science Degrees Between SVC and Rockford College

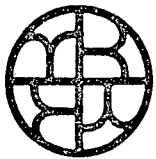

COMPACT BETWEEN  
ROCKFORD COLLEGE AND SAUK VALLEY COLLEGE

The Board of Trustees, administration and faculty of Rockford College affirm that a student who has been granted an Associate in Arts or an Associate in Science degree from Sauk Valley College, and who has been admitted to Rockford College for the purpose of pursuing a Bachelor of Arts, Bachelor of Fine Arts, Bachelor of Science, Bachelor of Science in Education or a Bachelor of Science in General Studies degree shall be granted full junior class standing at Rockford College, if the following qualifications are met:

1. that the transferring student has completed all requirements for an Associate in Arts degree or an Associate in Science degree from Sauk Valley College as stated in the 1979-80 catalog;
2. that the transferring student plans to major or to specialize in an area of study in which he or she has completed recommended lower division courses in the intended major or area of specialization which are equivalent to those taken by current Rockford College students;
3. that Rockford College has a program in the transferring student's intended major or specialization.

Note 1. Rockford College will accept in transfer all course work for which a passing grade has been earned provided that a 2.0 (C) average is a requirement for receipt of the Associate in Arts or Associate in Science degree. As a part of the admissions process, the student's transfer transcript will be analyzed and courses applied whenever possible to meet the Rockford College general degree and major requirements. All other courses will be accepted as elective hours.

Note 2. Specific analysis of the prevailing (1979-80) general education requirements for the Sauk Valley College A. A. and A. S. degrees indicates only two areas where the Sauk Valley College student does not fully meet the Rockford College B.A., B.F.A., and B.S. general degree requirements whose completion is expected within the four year plan of study. Such transfer students are processed in a manner consistent with those whose initial matriculation was at Rockford College.

The specific areas mentioned above are:

- (1) Physical Education - 1 year, P.E. 88/89 or 98/99 or equivalent (i.e., 2 semester hours of credit in physical education).
- (2) Art Distribution (6 hours taken from one or more of the following departments: Art, Dance, Music or Theater Arts/Speech and Language and Literature Distribution (8 hours - a composite total of 14 semester hours)

The Interim and Forum Series requirements of Rockford College for Sauk Valley College transfers are computed in a pro-rated manner equivalent to regular junior standing.

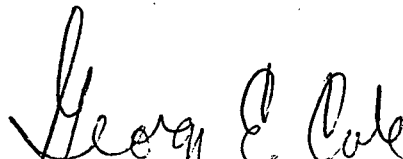


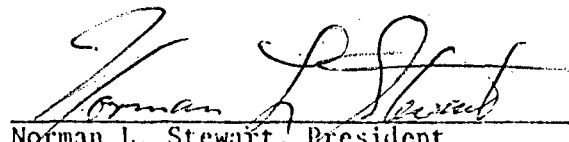
Note 3. Specific analysis of the prevailing (1979-80) general education requirements for the Sauk Valley College A.A. and A.S. degrees indicates only two areas where the Sauk Valley College student does not fully meet the Rockford College B.S. Ed. and B.S.G.S. general degree requirements whose completion is expected within the plan of study for the baccalaureate degree. Such transfer students are processed in a manner consistent with those whose initial matriculation was at Rockford College.

The specific areas mentioned above are:

- (1) Arts Distribution (6 hours taken from one or more of the following departments: Art, Dance, Music or Theater Arts/Speech) and Language and Literature Distribution (21 hours including English 111 & 112 - a composite total of 27 semester hours ) - Sauk Valley English 101 & 103 (6 hours) and Humanities (6 hours) applied - balance of 15 hours needed.
- (2) Social Studies Division (15 semester hours) Sauk Valley requirement of 6 hours applies - balance of 9 hours needed.

Note 4. This compact is subject to annual review for renewal at the request of Sauk Valley College or Rockford College.

## ASSOCIATE IN LIBERAL STUDIES DEGREE

The Associate in Liberal Studies Degree is a non-specialized degree that is tailored to meet the needs and interests of the individual student. Both baccalaureate (transfer) and career education courses may be used to fulfill the requirements for this alternate degree program. The ALS Degree is designed for the student who may not want to work toward the more traditional AA, AS or AAS Degrees. While not intended to be a transfer degree, the ALS Degree is designed to enable the student to articulate with the Board of Governor's Degree Program and the Bachelor of Liberal Studies Degree Program at participating Illinois universities.

The specific requirements for the ALS Degree are listed as follows:

1. Complete a minimum of 64 semester hours of course work at the 100 level, or above, with an average grade of "C" or better.
2. Develop and fulfill a statement of educational goals and a specific written program of course work which must be approved and signed by the student, his or her counselor, and his or her advisor. This written program must be filled out and signed prior to the completion of the last 16 semester hours of course work that is to be used to satisfy the requirements for the degree.
3. Demonstrate proficiency in each of the following academic areas by completing at least 3 semester hours of course work in each area.
  - a. Communication and writing skills
  - b. The social sciences
  - c. The humanities
  - d. The natural sciences

Credit for prior work experience, credit by USAFI, CLEP, and credit by proficiency examination may be used for this degree in accordance with the current college policy as stated in the catalog.

4. A minimum of 16 semester hours of course work must be completed at Sauk Valley College.
5. Satisfy the state requirements regarding National, State and Local Government, the United States Constitution and the Illinois Constitution in accordance with existing college policy as stated in the catalog.

# ASSOCIATE IN LIBERAL STUDIES DEGREE

At the May meeting of the Illinois Junior College Board, guidelines for an Associate in Liberal Studies Degree were approved. They are as follows:

1. There is a need in the community colleges for an associate degree that is not primarily baccalaureate oriented (AA or AS) and not primarily occupational oriented (AAS). This new type of degree could cover the areas sometimes referred to as liberal studies, general studies, general education, and adult-continuing education. These courses may be taken for specific purposes or for their intrinsic value.
  2. The Associate in Liberal Studies Degree may include any associate degree level courses in the area of baccalaureate oriented, occupational, or general studies, but would not include any developmental or remedial courses nor any certificate-level courses.
    - a. At this time the IRHE and IJCB staff does not see the need for an associate degree in developmental and/or remedial studies.
    - b. There may be students in the Associate in Liberal Studies Degree program who may need developmental and/or preparatory courses as prerequisites to future study. Credit for such courses would not be applicable to the minimum semester or quarter hour requirement for the Associate in Liberal Studies Degree.
    - c. Developmental and/or remedial courses may be counted in certificate programs of two years or less in length.
    - d. Developmental and/or remedial courses should be defined as "readily identifiable elementary or secondary level courses."
  3. The Associate in Liberal Studies Degree could be accepted in all or in part at a four year college or university towards completion of the requirements for a baccalaureate degree, at the discretion of the four year college or university. The Associate in Liberal Studies Degree would not automatically be transferable to the four year college or university without review by the four year college or university.
  4. As in other community college associate degree programs, the Associate in Liberal Studies Degree may include many traditional and regular course offerings or may include many unique and unusual offerings in addition to including both traditional and nontraditional methods of delivery. (Thus, the Associate in Liberal Studies Degree may include a lot of radio, educational television, correspondence, independent study, seminar, workshop, and credit by examination work).
  5. As part of the degree approval process each college will identify its plan for developing an individualized program for the student when the student is admitted to this degree program subject to general guidelines developed by the IJCB staff and approved by the IJCB for the Associate in Liberal Studies Degree.
  6. Once the agreement has been defined by both advisor and student, it cannot be changed except by joint agreement of the advisor and the student.
  7. Method of delivery of instruction, independent study, external degree, co-operative agreement with other institutions, and other types of flexibility in higher education curriculums will be appropriate to this degree if it is part of the contract between the college and student when that student's degree program is developed or changed at a later date by mutual agreement.

I am sure that the Board members will recall some confusion that existed last year with the ski classes at Plumtree. To avoid this confusion this year, we are recommending the following for Board approval:

1. The college will charge each student enrolled in the one credit hour ski course a total of \$48.00. \$20.00 of this will be for tuition and \$28.00 will be for lab fees.
2. The college will then pay Plumtree \$48.00 for every student. This would cover all instructional costs and other fees (such as lift tickets, rental equipment, etc.).
3. The college would receive state funding of about \$23.00 per credit hour.

RECOMMENDATION: Board approval of the above arrangement with Plumtree Ski School for Sauk Valley ski courses.
