

Call to Order: Chair Fisher called the meeting to order at 7:00 p.m. and the following members answered roll call:

Regular Session: At 8:57 p.m. the Board returned to regular session.


Discussion: The Board discussed revenue generation possibilities as follows:

TO: Board of Trustees

RE: Next Referendum

Since the recent defeat of our referendum, we have deliberated on the question of when to call for a vote again.

As you know we were originally impressed by the argument to avoid the March 20th (primary) election in favor of the November 6th (presidential) election. The principal arguments against the March 20th election was the risk of over exposure to the question and the appearance of Sauk deafness to the message of the recent November 8th vote.

I've reassessed the range of arguments and have personally concluded that we should now exercise our option to go on the March 20th ballots. For these reasons:

1. We must keep the issue before the people. Our need is real. The alternatives are serious. Only a positive vote is the answer to maintaining the college.
2. A March referendum will be a "real-life" measure of the advantage of a larger turnout at the polls and give us a measure of whether to go all out next November 1984 or in February of 1985.
3. We owe it to our students and staff to be persistent in pursuing a successful vote as an alternative to the retrenchment and restrictions which can lead to irrecoverable damage.

Should the Board concur in this conclusion the action must be taken at the Monday night, January 9th meeting.

Please be prepared to act on this question.
