December 16, 1985

The Board of Trustees of Sauk Valley College met in regular meeting at 7:00 p.m. on December 16, 1985 in Room 2K2 of Sauk Valley College, Route #5, Dixon, Illinois.

Call to Order: Chair Groharing called the meeting to order at 7:00 p.m. and the following members answered roll call:

Minutes: It was moved by Member Simpson and seconded by Member Peterson that the Board approve the minutes of the November 18 meeting as presented. In a roll call vote, all voted aye. Motion carried.

Treasurer's Report: It was moved by Member Simpson and seconded by Member Borell that the Board approve the Treasurer's Report as presented. In a roll call vote, all voted aye. Motion carried.

Disbursements: It was moved by Member Peterson and seconded by Member McDonald that the Board approve the disbursements in the following amounts:

Resolution on
Tax Abatement:

The Board was asked to consider a proposed resolution prepared by the Commerce Towers Group of Dixon to abate college property taxes per the attached ten year plan, which calls for a freeze on the assessment of taxes for the first five years and a graduated increase of taxes over the final five years of the plan.

It was moved by Member Simpson and seconded by Member Borell that the Board adopt the attached tax abatement resolution as presented. In a roll call vote, the following was recorded: Ayes: Members Berrettini, Simpson, Wolf, Groharing, and Borell. Nays: Members Andersen and McDonald. Member Peterson abstained. Motion carried.

Incubator
Contract:

Discussion was held on the consolidation of the Sauk New Business Development Incubator resources and redefining the incubator's direction. Dr. Garner reported that the corporation is requesting that it be released from its contract December 31, 1985. It was moved by Member Wolf and seconded by Member Berrettini that the Board authorize the administration to negotiate new lease arrangements to replace the present lease with the Sauk New Business Incubator, with a proposed effective date of December 31, 1985, and bring this matter back to the Board for action in January of 1986. In a roll call vote, all voted aye. Motion carried.

Request:

The Board was advised of the provisions of HB 993 which appropriates funds for repair and renovation projects at all Illinois Community Colleges. Dr. Garner reported that Sauk Valley College had been allocated \$89,443 which was determined on the basis of 22¢ per square foot. It was then moved by Member Andersen and seconded by Member Wolf that the Board authorize the administration to submit the Data Processing Renovation project for Build Illinois (HB 993) reimbursement. In a roll call vote, all voted aye. Motion carried.

VITAL Grant:

It was moved by Member Berrettini and seconded by Member Peterson that the Board accept funding of \$22,813 for the extension of the college Volunteers in Teaching Adult Literacy (VITAL) program. In a roll call vote, all voted aye. Motion carried.

Professional
Appointment:

The Board was informed that with the new grant mentioned above, the position of the Coordinator, Linda Kim, could now be increased to 3/4ths time. It was moved by Member Peterson and seconded by Member McDonald that the Board approve increasing the position of the coordinator, Linda Kim, from 1/4th time to 3/4ths time. In a roll call vote, all voted aye. Motion carried.

Advisory
Committees:

It was moved by Member Berrettini and seconded by Member McDonald that the members of the advisory committees on the attached listing be approved as presented. In a roll call vote, all voted aye. Motion carried.

Policy on
Jury Duty:

It was moved by Member McDonald and seconded by Member Wolf that the Board accept the policy noted below for first reading, with the addition of...."excluding mileage".

420.0 Jury Duty Leave

The Board shall pay the regular salary to a full-time employee called to serve as a juror, and the employee shall submit any reimbursement (excluding mileage) to the college.

Motion voted and carried.

Donations: It was moved by Member Wolf and seconded by Member Peterson that the Board accept the donation of a 1985 Buick Skylark Station Wagon from the BOC Engineering Center for General Motors Corporation. This vehicle is for instructional purposes and can never be titled, licensed, or driven on public roadways. Also approved was the donation of three small engines from the Kohler Company of Kohler, Wisconsin to be used in the small engine program at Dixon Correctional Center. Motion voted and carried.

Reports: Student Trustee Borell reported on the lecture series to be held on nuclear energy and abortions, and the student dance planned for Valentines Day.

Chair Groharing reported that the next ICCTA meeting would be the 17th and 18th of January and would include a workshop for all new trustees.

Foundation Liaison: Chair Groharing appointed Edie Peterson liaison to the Foundation Board.

Incubator: Ed Andersen said he would continue to be the Board representative to the incubator. It was moved by Member Wolf and seconded by Member Berrettini that the Board continue the appointments of Ed Andersen and Dean Donald Foster to the Sauk New Business Incubator for the present time. Motion voted and carried.

Allied Health Program: At this time, Assistant Dean Dick Holtam introduced members of the Allied Health division to the Board and they reported on the following:

Carol Hain - Director of Nursing reported on all aspects of the Nursing Program and the success of the nursing seminars that have been held during the Fall semester.

Stan Shippert reported on the Radiologic Technology program and the recent accreditation visit.

Harold Nelson gave a brief history of the Medical Laboratory Technician program at the college and the present status of the enrollment.

Reports:

President Garner reported on new certificates to be offered by the college, the receipt of the Small Business Development Grant, a report on tuition waivers, Education for Employment Update, progress on the CDB deficiency claim which looks very promising, and the bill recently signed by Governor Thompson which will extend the early retirement option.

Executive Session:

At 9:20 p.m. it was moved by Member Wolf and seconded by Member Peterson that the Board adjourn to executive session to discuss the appointment, employment, or dismissal of an employee. Motion voted and carried.

Regular Session:

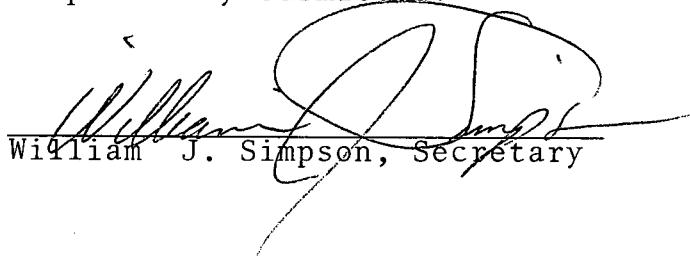
The Board returned to regular session at 10:31 p.m.

RESOLUTION FOR TAX ABATEMENT

The Board is asked to consider a proposed resolution prepared by the Commerce Towers Group to abate the college property taxes on the property commonly known as Commerce Towers, located in Dixon. The District would receive the monies it would normally be entitled to for the levy 1985, payable in 1986, but as it is drawn, from that point in time forward, the College will receive the exact same amounts to and through the levy in 1995, payable in 1996. Thus, this resolution actually freezes the dollar amount of taxes for a definite period. A similar version is under consideration by all the other taxing bodies involved.

The administration has met with the Commerce Towers group to discuss their request, as prescribed in the Board Policy 306.01.

The Board will need to respond to this request.

RESOLUTION RE ABATEMENT OF TAXES

WHEREAS, pursuant to P.A. 84-763, effective January 1, 1986, the Board of Trustees for Sauk Valley College has the authority to abate any portion of its taxes on the property of any commercial firm that was newly created within the State of Illinois in the immediately preceding calendar year or for an expanded previously existing facility; and

WHEREAS, said abatement may not exceed a period of 10 years and the total aggregate amount of abated taxes for all taxing districts combined cannot exceed \$1,000,000.00; and

WHEREAS, there has been a request to abate a portion of taxes on the property commonly known as Commerce Towers; and

WHEREAS, the Board of Trustees has made a determination that the assessed valuation of said property in 1985 is \$143,640.00; and

WHEREAS, the Petitioners have represented to this Board that the proposed project and use meets the requirement of the said Act to permit the lawful abatement of taxes; and

WHEREAS, the Board of Trustees hereby determines that under the said circumstances it would be in the best interests of Sauk Valley College to abate the taxes on said property commonly known as Commerce Towers, as provided herein.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. Board of Trustees for Sauk Valley College does hereby determine that the assessed valuation of the property hereinabove described, and commonly known as Commerce Towers, is \$143,640.00.

2. That the property for which this abatement shall affect is legally described as follows:

See Exhibit A which is attached hereto and made a part hereof.

("Commerce Towers property")

3. That commencing with the tax year 1986, and continuing thereafter to and through the year 1991, inclusive, the Board of Trustees does hereby freeze the assessed valuation of the Commerce Towers property to an amount equal to the assessed valuation of the Commerce Towers property for the year 1986.

4. That commencing with the tax year 1992, the Commerce Towers property shall be assessed an amount which equals the 1986 assessed valuation plus 20% of the difference between the 1986 assessed valuation and the 1992 assessed valuation. That commencing with the tax year 1993, the Commerce Towers property shall be assessed an amount which equals the 1986 assessed valuation plus 40% of the difference between the 1986 assessed valuation and the 1993 assessed valuation. That commencing with the tax year 1994, the Commerce Towers property shall be assessed an amount which equals the 1986 assessed valuation plus 60% of the difference between the 1986 assessed valuation and the 1994 assessed valuation. That commencing with the tax year 1995, the Commerce Towers property shall be assessed an amount which equals the 1986 assessed valuation plus 80% of the difference between the 1986 assessed valuation and the 1995 assessed valuation. That commencing with the tax year 1996, the Commerce Towers property shall be assessed based on its then fair market value in like manner as other real estate as determined by the Lee County Supervisor of Assessments without regard to abatement.

5. That this Resolution is expressly contingent upon the following: (i) the City of Dixon issuing \$4,000,000.00 in Industrial Development Revenue Bonds on or before December 31, 1985, for the expansion and improvement of the Commerce Towers property; (ii) there shall be no change in title, legal or equitable, from and after December 31, 1985, without the prior written approval of the Board of Trustees of Sauk Valley College; (iii) the Commerce Towers property being improved and expanded as represented and used, during the term of this Resolution, as a medical clinic; and (iv) the Petitioners and proposed use qualify for tax abatement pursuant to Illinois Revised Statutes, and all steps have been taken to make abatement

as proposed herein valid. In the event said bonds are not issued before December 31, 1985, or in the event the legal or equitable ownership of the property is changed or in the event the property is not used for a medical clinic, the Board of Trustees reserves the right to terminate this Resolution in its entirety. In the event the Petitioners or the proposed use do not meet the requirements of law to permit abatement, or if the Petitioners shall fail to take any steps necessary to effect the abatement provided herein, this Resolution shall be null and void and Petitioner shall repay any taxes improperly abated.

6. That the Secretary of the Board of Education is hereby authorized and directed to file a certified copy of this Resolution with the Lee County Clerk, Lee County Supervisor of Assessments, and Lee County Treasurer ordering the abatement of the portion of the taxes on the Commerce Towers property as hereinabove provided.

7. That this Resolution shall terminate without further action by the Board of Trustees when the total aggregate amount of abated taxes on the Commerce Towers property for all taxing districts combined exceeds \$1,000,000.00.

8. That this Resolution shall be effective January 1, 1986.

PARCEL 1: Lots 1, 2, 3, 4, 8 and 9, all in Block 3, also, that portion of the public alley known as Commercial Alley lying between the Westerly line of Lots 3 and 8 in Block 3 and the Easterly line of Lots 1 and 8 in Block 3, (also being the Westerly line of Crawford Avenue) all in the Original Town, now City of Dixon;

RELEASE FROM INCUBATOR CONTRACT

The Sauk New Business Development Incubator is in the process of consolidating its resources and redefining its direction. Lack of funds make it impossible to continue in its present form.

Sauk has the distinction of being both a partner in the Incubator Corporation, as well as the leasing the buildings T-1 and T-2 to the Incubator Corporation.

The Corporation is requesting that it be released from its contract December 31, 1985 and that the rental obligation the lease calls for be cancelled.

The rental forgiveness would be a contribution-in-kind that the college can make without cash involvement. Each of the other sponsors are being asked for additional financial support to meet the Incubator obligation.

RECOMMENDATION: It is recommended that the Sauk New Business Development Incubator be released from its master lease December 31, 1985 provided a new lease is negotiated for the proposed consolidation of the Incubator operation into T-2, or all Incubator operations vacate both buildings by the same date.

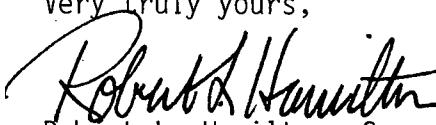

Ms. Kim served as a Peace Corps Volunteer for two years, taught and served as an ESL tutor in Seoul Korea for several years, served as a volunteer organizer of support groups at a hospital for four years, worked as a substitute teacher for two years in Dixon and as an office manager in Sterling for a year and one-half.

3. References

Ms. Kim has become acquainted with former members of the counseling department when she observed their work in career counseling. Dr. Robert Nejedlo, Professor at Northern Illinois University characterized her as "very bright, sincere, dedicated, competent, committed, and very serious about her work."

4. Personal Qualifications

Ms. Kim demonstrates sincere interest in working with people in a helping relationship. She appears to be a very altruistic person who has dedicated a major part of her adult life to helping others, often as a volunteer as was the case in the Peace Corps. Her personal and professional recommendations are of the highest order. In addition, she has experience as a coordinator of volunteers as well as that of serving as a volunteer.

5. Application Process

Ms. Kim has been serving as a part-time Coordinator of the VITAL Program during the past year. This program has been funded by Title XX and the Federal E-A Grant. The position was advertised and a screening process carried out in November of 1984 to fill this position. Ms. Kim wrote the grant to expand the literacy program and was successful in obtaining the Secretary of State, Illinois State Library Grant in the amount of \$22,813 to fund this program. Ms. Kim is being recommended to fill the three-fourths time position built into this grant.

Ms. Kim is an excellent coordinator and teacher in the adult literacy area. She brings a wealth of valuable experience to this position. She presents the image of a first rate professional educator and is highly regarded by all who have worked with her.
