Bids: It was moved by Member McDonald and seconded by Member Groharing that the Board (subject to DOC budget amendment) award contracts using DOC funds to John A. Loos Sons, Inc. in the amount of \$7,600 to furnish and install a cooling unit in the education building at the Dixon Correctional Center; \$2,826 to Mascal Electric, Inc. to completed all the necessary electrical work; and up to a total of \$1,044 to John A. ICCTA representative Groharing reported on the Annual ICCTA Convention to be held in June in Springfield. He also reported that the ICPCCP had officially expressed its appreciation to Dr. Behrendt for the fine professional development programs which he had scheduled for the past year. In fact he did such a good job that they reappointed him Chairman of the Professional Development Committee for the 1988-89 year.

Mr. Groharing reported that he had attended the April Foundation meeting at which time Robert Farrell (Assistant Director of Planning and Resource Development) was introduced; the Foundation had set a meeting for May 26 to discuss the Title III Endowment Challenge Grant; and decided to hold a Fund Raising Workshop at the college on June 21.

Board Chair Andersen noted that he would be distributing presidential evaluation forms and he would appreciate it if the Board would return them to him in the next two weeks. The president's evaluation will be scheduled for an executive session from 6 to 7 p.m. on Monday, June 27, 1988.

President Behrendt reported that the first issue of the Sauk Talk (student newspaper) had been printed and distributed; that Doris Cox had done a survey on services in the College Small Business Center and results were favorable; that roof repairs for college buildings will be bid next week; and that the college Indo-Chinese Program would conclude this June after nine years.

Executive Session: At 8:40 p.m. it was moved by Member Peterson and seconded by Member Groharing that the Board adjourn to executive session to discuss the appointment, employment, or dismissal of an employee. In a roll call vote, all voted aye. Student Trustee Peck advisory vote: aye.

Administrative Salaries: It was moved by Member Simpson and seconded by Member Peterson that the members of the administrative staff who have been evaluated satisfactorily and recommended for reappointment and a raise, be granted a salary increase of six per cent. In a roll call vote, the following was recorded: Ayes: Members Groharing, Peterson, Simpson, Yemm, Wolf and Andersen. Nays: Member McDonald. Motion carried. Student Trustee Johnson advisory vote: aye.

Classified Salaries: It was moved by Member Simpson and seconded by Member Groharing that the Board approve a salary increase of six per cent for all classified staff members who have been evaluated satisfactorily and recommended for reappointment and a raise, and that the attached classified salary be approved for 1988-89. In a roll call vote the following was recorded: Ayes: Members Groharing, Peterson, Simpson, Yemm, Wolf and Andersen. Nays: Member McDonald. Motion carried. Student Trustee Johnson advisory vote: aye.

Adjournment: Since there was no further business, it was moved by Member Wolf and seconded by Member Yemm that the Board adjourn. The next regular meeting will be at 7 p.m. on June 27 in the third floor Board Room. This meeting will be preceded at 6 p.m. by an executive session to conduct the presidential evaluation. SUBJECT: Pathfinder bids

Bids have been solicited for the printing and direct mailing of the Pathfinder class schedules for the 1988-89 year. The mailers will be produced in the form of five 24-page newsprint booklets.

A legal notice regarding the bidding was published in the Dixon Telegraph and Sterling Daily Gazette. In addition, direct invitations with printing specifications were extended to the following:

<u>Dixon Telegraph</u>	(Dixon)
<u>Castle Communications</u>	(DeKalb)
<u>Carroll County Review</u>	(Thomson)

Two bids were received:

<u>Dixon Telegraph</u>	\$20,500	(\$4,100 each)
<u>Carroll County Review</u>	.	\$18,667	(\$3,733.40 each)

This is the first year in some time that the Dixon Telegraph was not the low bidder. However, the Carroll County Review has experience with newsprint booklet schedules like the Pathfinder. Most recently they printed Highland Community College's schedule and Dr. Ray Searby, dean of student development there, said he was most happy with their performance. The Review's bid this year of \$18,667 is down from the Telegraph's current contract with us for \$20,100.

I recommend acceptance of the low bid of \$18,667 submitted by the Carroll County Review in Thomson, IL.

DCC AIR CONDITIONING BIDS

BUILDING REPAIRS

During the course of our construction defects project, we might occasionally discover other repair needs which could be performed more effectively and more efficiently when contractors are available here. Some of these needs could become apparent and require an immediate decision for their completion.

Therefore, it is wise for us to have prior Board approval to be able to spend some money as necessary with the following assurances:

1. The work would be needed and/or beneficial to the college;
2. Sauk funds will not be used when there is a possibility of using State funds;
3. The cost of any single project will not exceed \$5,000;
4. Work requests will be reviewed by our staff, the architect, and the contractor.

RECOMMENDATION: Board of Trustees approval to spend up to \$40,000 from operating funds to authorize construction work based on the above assurances and with the stipulation that any such work completed will be reported to the Board of Trustees at subsequent meetings with project description and cost.

**MEMORANDUM**

TO: Dr. Behrendt DATE: May 13, 1988
FROM: Robert Edison *Bob* SUBJECT: Building Repairs

The deficiency project on the building is progressing according to schedule and hopefully money will be released well before the end of May.

In having reviewed the repairs for the building as well as many other repairs and suggestions, it appears to me that project needs will arise which should be performed at the time we have contractors available at the College location. This factor coupled with the observation that construction is rarely completed in accordance with a strict schedule, plus the fact that contingency work and/or unknown elements arise that need attention compel me to make the following recommendation coupled with responsible assurances that monies will not be wasted needlessly nor will we ever use Sauk funds when there is a possibility of using state funds.

Assurances

1. Work would be needed and/or beneficial to Sauk Valley Community College.
2. Cost of any single project will never exceed \$5,000.
3. Work requests will be reviewed by ourselves, the architect and the contractor.

The only example that I can now give you under work that would be projected is represented by a description of an order to clean, tuck point and seal the masonry wing walls at the Automotive Body Shop area. This specific work was the only recommendation for contingency work that was "kicked out" by CDB. It was estimated to cost \$3,100 at the time we submitted same.

Recommendation: I would like to recommend Trustee approval to budget an amount of \$40,000 for me to authorize construction work based on the foregoing assurances, with the stipulation that all work will be reported to the Board of Trustees in terms of project description and dollars cost.

TITLE III ENDOWMENT CHALLENGE GRANT

Title III of the Higher Education Act provides for an Endowment Challenge Grant Program. Basically, this grant challenges the college to raise local non-governmental funds over an eighteen month period and this amount will be matched by the Federal Government. The total goes into the college's endowment fund (held by the SVCC Foundation) and the principal cannot be touched for a period of twenty years, but one half the interest earned each year can be used for educational purposes.

As you will recall, we were approached in early 1987 about the possible location of a cancer care center (operated jointly by KSB and CGH) on our campus. Since that time, much exploration has been done by the two hospitals and, as the attached correspondence indicates, they would still like to consider using some of our land.

Depending upon the exact location of the five acres they need, I am in favor of locating the center here under at least the following three conditions, listed in ascending order of importance:

1. Our name should be associated with the facility-- such as Sauk Valley Community College Cancer Treatment Center;
2. The building must be architecturally compatible with our current buildings; and
3. Our Allied Health students must have access to the facility as a clinical site for instructional/ training purposes.

Obviously, Ed Andersen is aware of this letter and would like to see it discussed at our Board meeting. It might be appropriately considered under "Other Actions" as H-5.

If you recall, Mr. Darryl Vandevort, Vice-President at KSB, and I spoke to you quite some time ago about our Cancer Center project and our desire to locate it at or near Sauk Valley College. Since that time, we have investigated our options on land near the college and have met with obstacles on all available sites. The obstacles include: (1) overpriced land, (2) unacceptable contingencies, and (3) an inability to purchase only the five acres we need and can afford.

Although we have not ruled out any of the three above listed options the prospects of successful negotiations appear slim. Therefore, I would appreciate it if you and your Board of Directors would discuss and consider the possibilities of us locating our Cancer Treatment Center on SVC property through a sale or lease arrangement.

We have a target date of November 1988 to have this service available. The probabilities of achieving that goal are remote since we cannot file our Certificate of Need with the State until we have a site identified. If we are to have any chance at meeting our November target date, we need to conclude our site selection very soon. I would appreciate it if you could get this item on your agenda for your Monday, 23 May 1988, meeting.
