SAUK VALLEY COMMUNITY COLLEGE BOARD OF TRUSTEES MEETING MINUTES

September 26, 1988

The Board of Trustees of Sauk Valley Community College met in regular meeting at 7:00 p.m. on September 26, 1988 in the third floor Board Room of Sauk Valley Community College, 173 Illinois Route #2, Dixon, Illinois.

Call to Order:

Chair Andersen called the meeting to order at 7:00 p.m. and the following members answered roll call:

Minutes:

It was moved by Member McDonald and seconded by Member Groharing that the minutes of the August 29 meeting be approved as presented. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

President's Report:

President Behrendt reported on the following: a Northwest ICCTA Program Interest Questionnaire to be completed by Board members; a letter of appreciation from the former publisher of the Fulton Journal for the current Pathfinder; enrollment showing a 1.8% increase in credit hours with a decline in head count; the receipt of an Endowment Challenge Grant which reserves \$250,000 for the college pending the completion of certain stipulations and the raising of \$250,000 in private funds; a report by Karen Kylen on the status of the funds expended under the HEA Title III Project; total funds expended to date for construction defects; an articulation agreement with Mount St. Clare College; that he had been appointed

vice-chair of the Sterling United Way, elected second vice-president of the Council of North Central Community Junior Colleges, and elected to the Board of Directors of the Sterling Chamber of Commerce.

Treasurer's Report:

It was moved by Member Simpson and seconded by Member McDonald that the Board approve the Treasurer's Report as presented. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

Payroll:

It was moved by Member Groharing and seconded by Member Peterson that the Board approve the payroll of August 31 in the amount of \$114,943.83 and the payroll of September 15 in the amount of \$182,662.20. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

Dixon/Lee County Enterprise Zone:

The Board discussed the request from the City of Dixon to abate a portion of taxes on real property located within their enterprise zone. It was moved by Member Wolf and seconded by Member Groharing that the Board continue with the present college policy and handle each abatement request on a case-by-case basis. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

Roofing Project: It was moved by Member Groharing and seconded by Member Simpson that the Board approve the attached resolution to be sent to the ICCB and the Office of Education requesting funds from the Protection, Health and Safety Act Fund in order to continue with the roofing project on the current facility. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

Executive Session: At 7:40 p.m. it was moved by Member McDonald and seconded by Member Peterson that the Board adjourn to executive session to discuss the appointment, employment or dismissal of an employee. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

Regular Session: The Board returned to regular session at 7:55 p.m.

Part-time Faculty: It was moved by Member Yemm and seconded by Member McDonald that the Board approve the attached list of part-time faculty as presented. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

Donation: It was moved by Member Groharing and seconded by Member Wolf that the Board accept the donation of two IBM Word Processors and one NCR Teller Machine from the Central National Bank and nine boxes of computer paper from the North Western Illinois Center for Independent Living. Motion voted and carried. Student Trustee Johnson advisory vote: aye.

Intercollegiate Athletics Program: The Board discussed the possibility of reinstating baseball in the 1989-90 intercollegiate athletics program and the need for more tuition waivers to attract outstanding student-athletes. It was moved by Member Peterson and seconded by Member Simpson that the Board approve increasing the number of

student-athlete tuition waivers from 52 to 64 (effective with the 1989-90 school year) if the stipulations in the attached memorandum are met. Should the Booster Club have a problem in raising the funds for the first year start-up costs of \$12,000, and/or the college is unable to hire qualified coaches, the additional 12 tuition waivers would not be used for any other purpose. In a roll call vote, the following was recorded: Ayes: Members Groharing, McDonald, Peterson, Simpson, Yemm and Andersen. Nays: Member Wolf. Motion carried. Student Trustee Johnson advisory vote: aye.

Reports: Student Trustee Johnson reported that plans were underway for the annual Pow Wow Day to be held September 28 and that the Student Senate would once again sponsor the Bloodmobile in October.

ICCTA representative Groharing presented the attached written report and reminded the Trustees of the Northwest Regional Meeting of the ICCTA at Highland College on October 27.

Board Chair Andersen reported that the Cancer Treatment Clinic has had two donations of land.

November Meeting: The November meeting will be changed to November 21.

Adjournment: Since the scheduled business was completed, it was moved by Member Yemm and seconded by Member Peterson that the Board adjourn. The next regular meeting will be 7 p.m. on October 24, 1988. In a roll call vote, all voted aye. Motion carried. Student Trustee Johnson advisory vote: aye.

The meeting adjourned at 8:31 p.m.

Mount St. Clare is planning to add B.A. degrees in liberal arts areas in the near future. When that occurs we will develop additional agreements with them.

DIXON/LEE COUNTY ENTERPRISE ZONE

The city of Dixon and a portion of unincorporated Lee County received State designation as an Enterprise Zone on July 1, 1987. The purpose of an Enterprise Zone program is to encourage industrial and commercial growth through expansion and new construction by offering state and local incentives. The most attractive incentive is the abatement of real estate taxes. The city of Dixon and Lee County, by adoption of an ordinance, have provided for a five year 50% abatement on a graduated rate of 100% of the value of the improvements for the first assessment year, 80% for the second year, and so forth.

At their August Board meeting, the Dixon Public School District passed a resolution agreeing to abate that portion of their taxes on real property located within the enterprise zone which applies to EZ improvements. Attached is a similar resolution for the Sauk Valley Community College Board's consideration.

However, please note the comments offered by Attorney Pace. If the attached resolution is approved, it would conflict with our Policies 306.01 and 307.01 as they apply to tax abatement requests made from the Dixon/Lee County Enterprise Zone. Therefore, approval of the current resolution would necessitate amendment to our existing policies.

RECOMMENDATION: Board discussion of the attached resolution.

I have reviewed the materials sent to you by the Lee County Enterprise Zone administrator. You can certainly place that on the Board's agenda for its consideration and it would appear appropriate to do so. Whether or not the Board wishes to participate in that particular abatement policy is a matter of the Board's discretion. At this point, however, I would remind the Board that it already has two policies in force, one the general abatement policy, policy 306.01, and also a specific policy for Lee County which is policy 307.01. It would appear to me that adoption of the request from the enterprise zone would require a revision of the Board's standing policies because there are substantive differences. For example, the formulas are different, and the ability to review matters on a case by case basis would be totally terminated by the policy proposed by the enterprise zone.

RESOLUTION
SAUK VALLEY COMMUNITY COLLEGE
SCHOOL DISTRICT #506

WHEREAS, the County of Lee and the City of Dixon have made known to Sauk Valley Community College, School District #506 of the designation of an Enterprise Zone for a portion of the territory which lies within the unincorporated area of Lee County and the Corporate Limits of the City of Dixon.

WHEREAS, both the initial designation of an Enterprise Zone pursuant to the Illinois Enterprise Zone Act, Illinois Revised Statutes, Chapter 67-½, par 601, et seq, and the eventual success of an Enterprise Zone depend upon community support and the nature of incentives to be offered; and

WHEREAS, the public taxing authority concurs with the intent of the act to induce businesses to construct, improve and expand businesses, commercial and manufacturing facilities by offering financial incentives in the form of property tax abatement.

WHEREAS, this public taxing authority finds that Enterprise Zone designation will serve the interest of all local taxing authorities and the entire community by stimulating economic revitalization;

NOW, THEREFORE, BE IT RESOLVED BY THE SAUK VALLEY COMMUNITY COLLEGE, SCHOOL DISTRICT #506:

Section 1. That Sauk Valley Community College, School District #506 hereby agrees to abate that portion of it's taxes according to limitations and conditions set forth in Section 6 of the City of Dixon Ordinance #1350 and Lee County Ordinance as the same have hereinbefore and may hereafter be amended on real property located in the Enterprise Zone resulting from an increase in assessed valuation which is attributable to the construction of improvements or to the renovation or rehabilitation of existing improvements and subject to the following limitations:

- (a) The abatement shall apply to the taxes corresponding to an increase in assessed valuation after improvements (either new construction or renovation or rehabilitation) have been duly assessed and said abatement shall not exceed the amount attributable to the construction of the improvements and the renovation or rehabilitation of existing improvements.
- (b) The abatement shall pertain only to that parcel within the Enterprise Zone which has been improved after the designation of the Enterprise Zone provided, however, that no such abatement shall be applicable to any such improvement project located within the boundaries of the Tax Increment Redevelopment Project areas (Ordinance #1424 amending Ordinance #1350).

- (c) The abatement for a particular project shall be in effect only for a period of five years commencing with the first tax year after the improvements have been assessed. Such abatement shall be at a rate of: 100 per cent of the value of the improvements for the first assessment year which the improvements are made; 80 per cent of the value of the improvements for the second assessment year; 60 per cent of the value of the improvements for the third assessment year; 40 per cent of the value of the improvements for the fourth assessment year; and 20 per cent for the fifth assessment year;
- (d) The abatement is allowed only for new physical improvements, to consist of new construction, rehabilitation, or renovation, the nature and scope for which building permits are required and have been obtained.
- (e) While the abatement is in effect, this public taxing authority will continue to receive all taxes corresponding to the equalized assessed valuation for the tax year immediately preceding commencement of the project.
- (f) Said abatement shall be in effect during and so long as the Enterprise Zone is certified by the State of Illinois.

Section 2. Further Action. The public taxing authority shall take all further action in order to abate taxes as contemplated herein, including but not limited to the adoption of further resolutions and the notification of the amount of the abatement each year to the County Clerk in Lee County.

Section 3. Conflict. All resolutions and parts of resolutions in conflict herewith are, to the extent of such conflict, hereby repealed.

**AN ORDINANCE ESTABLISHING AN ENTERPRISE ZONE
WITHIN THE CITY OF DIXON**

**SAID ENTERPRISE ZONE BEING A PORTION OF A LARGER
ENTERPRISE ZONE ENCOMPASSING CONTIGUOUS PORTIONS OF
THE CITY OF DIXON AND THE COUNTY OF LEE**

WHEREAS, the following Ordinance is adopted based upon the following premises, to-wit;

WHEREAS, the State of Illinois has enacted the "Illinois Enterprise Zone Act of 1982," to alleviate distressed economic conditions in certain depressed areas; and

WHEREAS, the health, safety and welfare of the residents of the City of Dixon are dependent, in part, upon a healthy, private section of the city's economy; and

WHEREAS, the development, growth and expansion of the private sector requires a cooperative and continuous partnership between government and the private sector; and

WHEREAS, there are certain areas in the city that need the particular attention of government, business and labor to attract private sector investment and directly aid the entire county and the residents thereof; and

WHEREAS, a disproportionate number of residents within the incorporated municipality of Dixon and adjacent areas of unincorporated Lee County, for several years have suffered pervasive poverty, unemployment and economic distress, related to the prolonged national recession, shifts of industries throughout the country, and a variety of other economic factors negatively affecting the incorporated and unincorporated areas mentioned above; and

WHEREAS, the members of this duly constituted legislative body are cognizant of the distressed conditions existing within this area and are desirous of alleviating these distressed conditions; and

WHEREAS, Lee County has indicated its willingness and desire to cooperate with the City of Dixon in designating portions of unincorporated areas in the county as an Enterprise Zone;

NOW, THEREFORE, BE IT ORDAINED, That the Dixon City Council hereby establishes an Enterprise Zone within its jurisdiction, said Enterprise Zone being a portion of a larger Enterprise Zone, encompassing contiguous portions of the adjacent areas of unincorporated Lee County, as indicated herein:

Section 1. Description: As established by the units of government and approved by the Illinois Department of Commerce and Community Affairs (DCCA). The area of the Enterprise Zone shall be as described in Exhibit A and as outlined in the map in Exhibit B, which exhibits are attached to this Ordinance and made a part hereof.

Section 2. Qualifications: The City of Dixon hereby declares and affirms that the zone area is qualified for designation as an Enterprise Zone in accordance with the provisions of the Illinois Enterprise Zone Act, and further affirms that:

- a. The zone area is a contiguous area;
- b. The zone area comprises a minimum of one-half square mile and not more than ten square miles in total area;
- c. The zone area is a depressed area;
- d. The zone area satisfies any additional criteria established by the Illinois Department of Commerce and Community Affairs;
- e. On the 8th day of December, 1986, a public hearing was conducted within the zone area on the question of whether to create the zone, what local plans, tax incentives and other programs should be established in connection with the zone, and what the boundaries of the zone should be, and that public notice was given in at least one newspaper of general circulation within the zone area, not more than 20 days nor less than 5 days before the hearing; and
- f. It addresses a reasonable need to encompass portions of more than one (1) municipality and adjacent unincorporated areas of the county.

Section 3. Enterprise Zone Designation: That the area described in Section 1, above, is hereby designated as an Enterprise Zone, subject to the approval of DCCA, in accordance with law.

Section 4. Term and Effect: This Ordinance shall be and become effective for a period of twenty (20) years, unless sooner rescinded or as otherwise amended, on the date that the area described in Section 1, above, is designated an Enterprise Zone by DCCA, in accordance with law.

Section 5. Sales Tax Deductions: Each retailer whose place of business is within the corporate limits of the City of Dixon and who makes a sale of building materials to be incorporated into real estate located in the enterprise zone by remodeling, rehabilitation or new construction, may deduct receipts from such sales when calculating the tax imposed pursuant to the "Municipal Retailers' Occupation Tax Act"; provided, however, that such remodeling, rehabilitation or new construction is of the nature and scope for which a building permit is required and has been obtained. The incentive provided by this Section shall commence the first day of the calendar month following the month in which

the Enterprise Zone is designated and certified, and shall continue for the term of the Enterprise Zone. Such deduction shall be allowed only for building materials incorporated into commercial, industrial or manufacturing property located within the zone area.

Section 6. Property Tax Abatement: The City of Dixon authorizes and directs the County Clerk to abate ad valorem taxes imposed upon real property, located within the Enterprise Zone area, upon which new improvements have been constructed or upon which existing improvements have been renovated or rehabilitated, subject to the following conditions:

a. The improvements or renovations are of the scope and nature for which a building permit is required and has been obtained;

b. Any abatement of taxes on any parcel shall not exceed the amount attributable to the construction of the improvements and the renovation or rehabilitation of existing improvements on such parcel;

c. Such abatement shall be allowed only for commercial, industrial or manufacturing property located within the zone area;

d. Such abatement shall be at the rate of: 100 per cent of the value of the improvements, for the assessment year in which the improvements are made; 80 per cent of the value of the improvements, for the second assessment year; 60 per cent of the value of the improvements for the third assessment year; 40 per cent of the value of the improvements, for the fourth assessment year; 20 per cent of the value of the improvements for the fifth assessment year; and

e. Such abatement shall continue and be in full force as set forth in this Section for any improvements which are completed within the term of the Enterprise Zone as specified in Section 4 of this enactment.

Section 7. Zone Management: Upon designation as an Enterprise Zone by the Illinois Department of Commerce and Community Affairs, a Management Organization comprised of the Chairman of the County Board and two members of the County Board, the Mayor of the City of Dixon and two members of the Dixon City Council will be formed. This Organization will be the governing body of the Enterprise Zone and will be responsible for all decisions within the Zone. The Zone Administrator will be the individual who will be responsible for the day-to-day implementations within the Zone and will be the liaison between the Management Organization, the Economic Development Committee and the Illinois Department of Commerce and Community Affairs.

Section 8. Management Organization: The Zone Administrator shall recommend to the Management Organization one or more

organizations that qualify as Designated Zone Organizations (DZO) under the provisions of the Illinois Enterprise Zone Act. Upon approval by the Management Organization, for a term of years set by the Management Organization, the DZO may:

- a. Provide a forum for business, labor and government action on enterprise zone innovations;
- b. Receive title to publicly-owned land;
- c. Solicit and receive contributions to improve the quality of life in the zone area; and
- d. Perform such other functions as the Management Organization may deem appropriate, not inconsistent with the Illinois Enterprise Zone Act.

Section 9. Zone Administrator: The position of "Zone Administrator" is hereby created. The Zone Administrator shall be the duly appointed and acting Community Development Director for the City of Dixon, who is an officer or employee of the City of Dixon. The duties of the Zone Administrator shall be performed in addition to the regular duties of the position of Community Development Director.

It shall be the power and duty of the Zone Administrator to:

- a. Supervise the implementation of the provisions of this ordinance and the Illinois Enterprise Zone Act;
- b. Act as a liaison between the County of Lee and the City of Dixon, the Illinois Department of Commerce and Community Affairs, designated zone organizations; and other state, federal and local agencies, whether public or private;
- c. Conduct an ongoing evaluation of the enterprise zone program and submit such evaluative reports on at least an annual basis to the Lee County Board Chairman, the Mayor of the City of Dixon and the Zone Management Organization;
- d. Promote the coordination of other relevant programs, including, but not limited to, housing, community and economic development, small business, financial assistance and employment training within the enterprise zone;
- e. Recommend qualified designated zone organizations to the Management Organization; and
- f. Have other duties as specified by either the Chairman of the County Board of Lee County, the Mayor of Dixon or the Management Organization.

BE IT FURTHER ORDAINED BY THE DIXON CITY COUNCIL THAT:

Section 10. The Mayor of the City of Dixon shall have and is hereby given authority to execute an Intergovernmental Agreement between the City of Dixon and Lee County which will indicate their willingness and desire to participate in the Enterprise Zone Program and which will set out the criteria for cooperation,

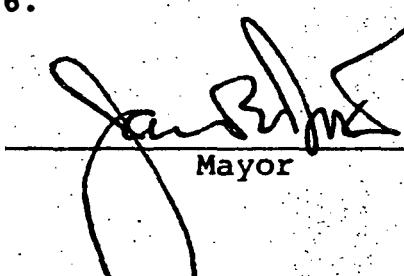
participation and management of said Enterprise Zone in keeping with the specifications and conditions of this Ordinance.

Section 11. This Ordinance, and every provision thereof, shall be considered separable, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

Section 12. All Ordinances and/or Resolutions, or parts thereof, in conflict herewith are hereby repealed.

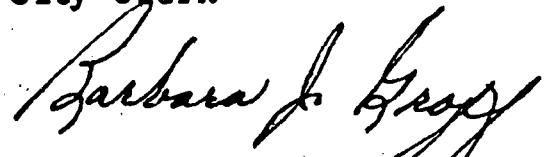

AN ORDINANCE ESTABLISHING AN ENTERPRISE ZONE
WITHIN THE COUNTY OF LEE

SAID ENTERPRISE ZONE BEING A PORTION OF A LARGER
ENTERPRISE ZONE ENCOMPASSING CONTIGUOUS PORTIONS OF
THE CITY OF DIXON AND THE COUNTY OF LEE

WHEREAS, the following Ordinance is adopted based upon the following premises, to-wit:

WHEREAS, the State of Illinois has enacted the "Illinois Enterprise Zone Act of 1982," to alleviate distressed economic conditions in certain depressed areas; and

WHEREAS, the health, safety and welfare of the residents of the County of Lee are dependent, in part, upon a healthy private section of the County's economy, and

WHEREAS, the development, growth and expansion of the private sector requires a cooperative and continuous partnership between government and the private sector, and

WHEREAS, there are certain areas in the County that need the particular attention of government, business and labor to attract private sector investment and directly aid the entire county and the residents thereof, and

WHEREAS, a disproportionate number of residents within the incorporated municipality of Dixon and adjacent areas of unincorporated Lee County, for several years have suffered pervasive poverty, unemployment and economic distress, related to the prolonged national recession, shifts of industries throughout the country, and a variety of other economic factors negatively affecting the incorporated and unincorporated areas mentioned above, and

WHEREAS, the members of this duly constituted legislative body are cognizant of the distressed conditions existing within this area and are desirous of alleviating these distressed conditions, and

WHEREAS, Lee County has indicated its willingness and desire to cooperate with the City of Dixon in designating portions of unincorporated areas in the county as an Enterprise Zone,

NOW, THEREFORE, BE IT ORDAINED, that the Lee County Board hereby establishes an Enterprise Zone within its jurisdiction, as indicated herein:

Section 1. Description: As established by the units of government and approved by the Illinois Department of Commerce and Community Affairs (DCCA). The area of the Enterprise Zone shall be as described in Exhibit A and as outlined in the map in Exhibit B, which exhibits are attached to this ordinance and made a part hereof.

Section 2. Qualifications: The County of Lee hereby declares and affirms that the zone area is qualified for designation as an Enterprise Zone in accordance with the provisions of the Illinois Enterprise Zone Act, and further affirms that:

- a. The zone area is a contiguous area;
- b. The zone area comprises a minimum of one-half square mile and not more than ten square miles in total area;
- c. The zone area is a depressed area;
- d. The zone area satisfies any additional criteria established by the Illinois Department of Commerce and Community Affairs;
- e. On the 8th day of December, 1986, a public hearing was conducted within the zone area on the question of whether to create the zone, what local plans, tax incentives and other programs should be established in connection with the zone, and what the boundaries of the zone should be, and that public notice was given in at least one newspaper of general circulation within the zone area, not more than 20 days nor less than 5 days before the hearing; and
- f. It addresses a reasonable need to encompass portions of more than one (1) municipality and adjacent unincorporated areas of the county.

Section 3. Enterprise Zone Designation: That the area described in Section 1, above, is hereby designated as an Enterprise Zone, subject to the approval of DCCA, in accordance with law.

Section 4. Term and Effect: This Ordinance shall be and become effective for a period of twenty (20) years, unless sooner rescinded or as otherwise amended, on the date that the area described in Section 1, above, is designated an Enterprise Zone by DCCA, in accordance with law.

Section 5. Sales Tax Deductions: Each retailer whose place of business is within the unincorporated limits of the County of Lee and who makes a sale of building materials to be incorporated into real estate located in the Enterprise Zone by remodeling, rehabilitation or new construction, may deduct receipts from such sales when calculating the tax imposed pursuant to the "County Retailers' Occupation Tax Act"; provided, however, that such remodeling, rehabilitation or new construction is of the nature and scope for which a building permit is required and has been obtained. The incentive provided by this Section shall commence the first day of the calendar month following the month in which the Enterprise Zone is designated and certified, and shall continue for the term of the Enterprise Zone. Such deduction shall be allowed only for building materials incorporated into commercial, industrial or manufacturing property located within the zone area.

Section 6. Property Tax Abatement: The County of Lee authorizes and directs the Lee County Clerk to abate ad valorem taxes imposed upon real property, located within the Enterprise Zone area, upon which new improvements have been constructed or upon which existing improvements have been renovated or rehabilitated, subject to the following conditions:

- a. The improvements or renovations are of the scope and nature for which a building permit is required and has been obtained;
- b. Any abatement of taxes on any parcel shall not exceed the amount attributable to the construction of the improvements and the renovation or rehabilitation of existing improvements on such parcel;
- c. Such abatement shall be allowed only for commercial, industrial, or manufacturing property located within the zone area;
- d. Such abatement shall be at the rate of: 100 per cent of the value of the improvements for the assessment year in which the improvements are made; 80 per cent of the value of the improvements for the second assessment year; 60 per cent of the value of the improvements for the third assessment year; 40 per cent of the value of the improvements for the fourth assessment year; 20 per cent of the value of the improvements for the fifth assessment year; and thereafter such abatement shall cease.
- e. Such abatement shall continue and be in full force as set forth in this Section for any improvements which are completed within the term of the Enterprise Zone as specified in Section 4 of this enactment.

Section 7. Zone Management: Upon designation as an Enterprise Zone by the Illinois Department of Commerce and Community Affairs, a Management Organization comprised of the Chairman of the County Board and two members of the County Board, the Mayor of the City of Dixon and two members of the Dixon City Council will be formed. This organization will be the governing body of the Enterprise Zone and will be responsible for all decisions within the Zone. The Zone Administrator will be the individual who will be responsible for the day-to-day implementations within the Zone and will be the liaison between the Management Organization, the Economic Development Committee and the Illinois Department of Commerce and Community Affairs.

Section 8. Management Organization: The Zone Administrator may recommend to the Management Organization one or more organizations that qualify as Designated Zone Organizations (DZO) under the provisions of the Illinois Enterprise Zone Act. Upon approval by the Management Organization, for a term of years set by the Management Organization, the DZO may:

- a. Provide a forum for business, labor and government action on enterprise zone innovations;
- b. Receive title to publicly-owned land;
- c. Solicit and receive contributions to improve the quality of life in the zone area; and
- d. Perform such other functions as the Management Organization may deem appropriate, not consistent with the Illinois Enterprise Zone Act.

Section 9. Zone Administrator: The position of "Zone Administrator" is hereby created. The Zone Administrator shall be the duly appointed and acting Community Development Director for the City of Dixon, who is an officer or employee of the City of Dixon. The duties of the Zone Administrator shall be performed in addition to the regular duties of the position of Community Development Director.

It shall be the power and duty of the Zone Administrator to:

- a. Supervise the implementation of the provisions of this ordinance and the Illinois Enterprise Zone Act;
- b. Act as a liaison between the County of Lee and the City of Dixon, the Illinois Department of Commerce and Community Affairs, designated zone organizations; and other state, federal and local agencies, whether public or private;
- c. Conduct an ongoing evaluation of the enterprise zone program and submit such evaluative reports on at least an annual basis to the Lee County Board Chairman, the Mayor of the City of Dixon and the Zone Management Organization;
- d. Promote the coordination of other relevant programs, including, but not limited to, housing, community and economic development, small business, financial assistance and employment training within the enterprise zone;
- e. Recommend qualified designated zone organizations to the Management Organization; and
- f. Have other duties as specified by either the Chairman of the County Board of Lee County, the Mayor of Dixon or the Management Organization.

BE IT FURTHER ORDAINED BY THE LEE COUNTY BOARD:

Section 10. The Chairman of the Lee County Board shall have and is hereby given authority to execute an Intergovernmental Agreement between the City of Dixon and Lee County which will indicate their willingness and desire to participate in the Enterprise Zone Program and which will set out the criteria for cooperation, participation and management of said Enterprise Zone in keeping with the specifications and conditions of this Ordinance.

Section 11. This Ordinance, and every provision thereof, shall be considered separable, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

Section 12. All Ordinances and/or Resolutions, or parts thereof, in conflict herewith are hereby repealed.

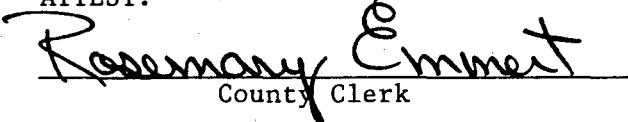

SAUK VALLEY COMMUNITY COLLEGE
PARTIAL REROOFING WORK (8797)

PROJECT DESCRIPTION

In 1988, the Sauk Valley College Board of Trustees initiated a phased program to correct the numerous roof leaks which have occurred since the original construction of the College building. In 1988, 18,800 square feet of reroofing was completed over the gymnasium as the first phase of reroofing the permanent College building.

The leaks are a result of splits in the built-up roofing felts, deterioration of the felts, flashing and counter-flashing leaks, leaks around roof drains and the resulting total deterioration of the poured-in-place asphaltic insulation. When the insulation deteriorates, the felt membrane loses adhesion and the splitting of the felts accelerates. Under the roofing bond of twenty years, the roofing contractor has returned to make patches and repairs, but the time limit of the bond is approaching its limit and the Board of Trustees has wisely entered into a programmed reroofing schedule. This project constitutes the second phase of the reroofing program.

We recommended the following method of roof membrane replacement:

- Remove present membrane and deteriorated roof insulation..
- Mechanically fasten to the present concrete deck a vapor barrier and sloping roof insulation in order to obtain an insulating value (R) of 20 average over the roof area and also to obtain a positive roof slope to the roof drains. By mechanically fastening the insulation, an FM and UL wind classification of I-90 can be obtained which is essential for the building located in the open country space.
- Adhere a new 60 mil EPDM (modified rubber) membrane to the insulation and repair all flashings and expansion joints in the area of the reroofing and perimeter.
- Obtain a 10-year warranty on the roofing system from the manufacturer of the membrane.
- Correct and repair damaged areas on the interior of the building caused by moisture penetration.

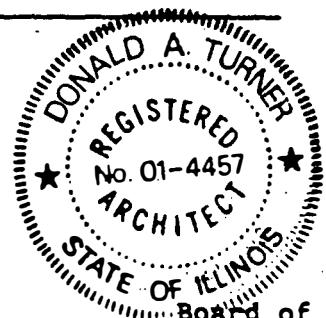

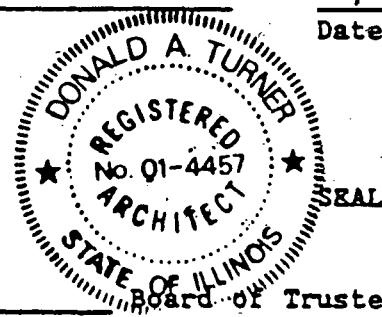

INTERCOLLEGIATE ATHLETICS PROGRAM

As the attached memo outlines, we would like to reinstate baseball in our 1989-90 intercollegiate athletics program. In order to do so, we need more tuition waivers to attract outstanding student-athletes who would like to play baseball for us.

RECOMMENDATION: It is recommended that the Board of Trustees approve increasing the number of student-athlete tuition waivers from 52 to 64, effective with 1989-90 school year.

In keeping with one of our Strategic Plan goals as well as the January 26, 1987 Board of Trustees Resolution supporting inter-collegiate athletics, we have explored the possibility of expansion of our athletic program. Given our philosophical commitment to sports, the enrollment increase among full-time students, and the outstanding 1987-88 athletic season, we believe it is timely to add baseball to our sports program.

Baseball seems the most logical addition at this time. First, there is a considerable and growing local interest in baseball and we continue receiving numerous inquiries concerning reinstating baseball at Sauk Valley. For example, both our former Director of Admissions, Al Hardersen, and Athletic Director, Frank Palumbo, reported that they have often been asked by prospective students and parents when we will be reinstating baseball. Further, baseball is currently an Arrowhead Conference sport. Blackhawk, Carl Sandburg, Kishwaukee, and Illinois Central all compete in Arrowhead Conference baseball and other area schools who would fit into a schedule would include Rock Valley, Illinois Valley, Waubonsee, DuPage, Elgin, Joliet, Morton, Oakton, Wright, and Clinton. Finally, the only current men's spring sport is tennis so we could use another. For all these reasons, baseball appears to be the logical addition to our sports program.

The approximate first year cost for baseball would be \$12,000. This would be a complete cost including facilities rental, officials, meals, travel, uniforms, equipment, insurance, and coaching stipends. A general discussion of this topic at our February 1988 retreat concluded with Board sentiment that we try to raise this amount for the first year through our Athletic Booster Club. At their March 25, 1988 meeting, the Booster Club agreed to make the solicitation of this money their first project. Further, the Student Services Committee has already pledged \$4,000 of their available funds toward reinstating baseball.

Specifically, therefore, we are suggesting the following course of action:

1. The Board of Trustees will be asked to increase our student-athlete tuition waivers from 52 to 64 in order to accommodate additional tuition waivers for baseball.
2. Following this action, we will immediately:
 - a. Work with our Booster Club to raise the necessary \$12,000 for the 1989-90 academic year;
 - b. Begin searching for a baseball coach and assistant coach; and
 - c. Implement publicity and recruitment efforts to attract worthy student-athletes to enroll for the 1989-90 school year.

It is understood that the college would need to make appropriate budgetary provision in 1990-91 and thereafter to support the baseball program and that this would cost \$10-12,000 per year. This funding could be provided in the operating budget or, since we will soon need a student activity fee increase, the money then could come from the student activity fee.

It is further understood that, should we fail to raise the necessary start-up costs and/or be unable to hire qualified coaches, the additional 12 tuition waivers would not be used for any other purpose.

We believe that we have started a winning athletic tradition at Sauk Valley Community College and that this has created a winning image with the public and helped our recruitment efforts. The addition of baseball appears timely and will enhance our athletic program.

SUBJECT: September 9th ICCTA Meeting

The meeting marked the beginning of the association's 88-89 year.

The Board of Representatives approved the goals that had been established by the Executive Committee at their planning session in July. They are:

1. To continue cooperative efforts with community college groups, such as the Council of Presidents, and the Illinois Community College Board.
2. Refine ICCTA activities in order to support the association's three goals of advocacy, public relations, and trustee development.
3. To encourage reflection of the art of trusteeship through a series of publications and seminars.
4. To explore the development of a proposal for equitable and adequate funding of all levels of Illinois public education, including, of course, community colleges.
5. To encourage the formation of a coalition to protect management rights, and to improve the climate of collective bargaining.

The various committees, meeting for the first time this year, reviewed last years efforts and established their priorities for the coming year.

The Minority Concerns Committee, which had been a ad-hoc group, has been made a standing committee. Among other issues, they will be addressing the problem of the lack of participation by minorities as faculty, administrators, and trustees.

The State Relations Committee will be focusing in a general nature on funding and management/labor relations issues, and specifically on limiting trustee liability, allowing boards to go into closed session for self evaluation, and providing insurance coverage for community college retirees.

There was a seminar on the advantages of purchasing group property and casualty insurance. Dr. Edison will be looking into this. I have copies of the handouts for anyone who would like to see them.

The Board began their meeting by observing a moment of silence in memory of William "Sid" Campbell who passed away recently. Sid had been chairman of the ICCB for the last 7 years, and was widely respected as a proponent of the community college system. The chair will be assumed by Toussant Hale Jr., a Chicago banker. The governor will appoint a replacement for the vacancy.

The petition of Evanston Twp. High School District to annex to Oakton Community College District was approved. This annexation will add 1 billion dollars in assessed evaluation to the Oakton District, which already has an assessed evaluation of 1 billion.

In a similar matter, both of which stem from the fact that all school districts in the state are required by law to be part of a community college district by 1990, a petition was heard, and denied, to hold a referendum to form a new community college district along the I-55 "corridor" to include Bloomington-Normal, Pontiac, and Lincoln. The request was denied because it would have asked for a 18.5¢ combined tax rate, which the board felt was inadequate for a new district. Referenda to form this district have already been defeated 4 times at various tax rates. Because of time constraints, the district will be formed by the ICCB. Probably at a 22.5¢ combined rate. Some school districts in this area may wish to join existing community college districts now that this decision has been made. It is questionable, however, that the ICCB will allow this area to be split up.

In other actions, the board approved:

1. The proposed legislative agenda during the next session.
2. New units of instruction for several colleges.
3. Community college extension courses; both out of state, and out of country.
4. Rules revisions regarding the Student Advisory Committee.
