June 27, 1990

The Board of Trustees of Sauk Valley Community College met in regular meeting at 7:00 p.m. on June 27, 1990 in the third floor Board Room of Sauk Valley Community College, 173 Illinois Route #2, Dixon, Illinois.

Call to Order: Chair Simpson called the meeting to order at 7:00 p.m. and the following members answered roll call:

Communication from Visitors: There was no communication to report.

Minutes: It was moved by Member Groharing and seconded by Member Densmore that the Board approve the minutes of the May 21 meeting as presented. In a roll call vote the following was recorded: Ayes: Members Andersen, Densmore, Groharing, Simpson, Wolf, and Yemm. Abstained: Member McDonald. Motion carried. Student Trustee Munson advisory vote: aye.

President's Report: President Behrendt reported to the Board that the college has been awarded a new Title IV Student Support Services grant for 3 years for a total budget of \$286,345; reviewed a recycling report which summarized our environmental efforts; that he had been selected as the second Vice President of the Sterling Chamber of Commerce board; and that on July 12th the college will be hosting a Founders Tea. The Board also discussed Policy 404.01 on Appointment of College Staff, Policy 405.01 on Appointment of Instructional and Administrative Personnel, and Policy 405.01 on Oral English Proficiency.

X-Ray
Laboratory Bids:

It was moved by Member Wolf and seconded by Member Yemm that the Board approve a contract with L & L X-Ray Service, Inc., for X-Ray laboratory equipment in the amount of \$59,258 with the SVCC Foundation to reimburse the amount of \$19,753 to the College and the balance to be paid from the 1990 fiscal

year's operating budget. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Executive Session: At 7:20 p.m., it was moved by Member McDonald and seconded by Member Groharing that the Board adjourn to executive session to discuss the appointment, employment, or dismissal of an employee, and collective bargaining matters. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Regular Session: The Board returned to regular session at 8:30 p.m.

Resignation: It was moved by Member McDonald and seconded by Member Wolf to accept with regret the resignation of Rhea Edge as Director of the SVCC Education Program at the Dixon Correctional Center. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Part-time Faculty: It was moved by Member Groharing and seconded by Member Yemm that the Board approve the attached list of part-time faculty for the 1990-91 school year. In a roll call vote the following was recorded: Ayes: Members Densmore, Groharing, McDonald, Simpson, Wolf, and Yemm. Abstained: Member Andersen. Motion carried. Student Trustee Munson advisory vote: aye.

Director of Nursing Education: It was moved by Member Yemm and seconded by Member Densmore that the Board approve the appointment of Rosemary Johnson to the position of Director of Nursing Education effective August 15, 1990 at a 12-month salary of \$34,500. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Classified Staff Salaries: It was moved by Member Groharing and seconded by Member Wolf that the Board approve a 7 per cent increase on Classified salaries for 1990-91 for those who receive a satisfactory or above rating on their annual evaluation. The College will do an area wide survey of

comparable grade level jobs and make a recommendation at a later date regarding the movement of the salary ranges. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Administrative Staff Salaries:

It was moved by Member Wolf and seconded by Member Densmore that the Board approve a 7 per cent increase on Administrative salaries for 1990-91 for those who receive a satisfactory or above rating on their annual evaluation. The College will do a state-wide survey of comparable administrative positions and make a recommendation at a later date regarding the movement of the salary ranges. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Title Changes:

It was moved by Member Densmore and seconded by Member Groharing that the Board approve the title change of Dean to Vice President for the three Deans and Assistant Dean to Dean for the three Assistant Deans. In a roll call vote, the following was recorded: Ayes: Members Andersen, Densmore, Groharing, Simpson, and Yemm. Nays: Members McDonald and Wolf. Motion carried. Student Trustee Munson advisory vote: aye.

Prevailing Wages Resolution:

It was moved by Member Andersen and seconded by Member McDonald that the Board approve the attached Resolution Establishing Prevailing Wages for Sauk Valley Community College District #506. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Administrative Calendar:

It was moved by Member Yemm and seconded by Member Groharing that the Board approve the attached Administrative Calendar for the 1990-91 year. In a roll call vote, all voted aye. Motion carried. Student Trustee Munson advisory vote: aye.

Jeff reported that the Student Senate had held elections in the Spring and would hold them again in the Fall to fill vacancies on the Senate; that recently Jim Burns and Neil Hartigan had visited the college for a question and answer session on drugs and alcohol problems on campus; and that the Senate was planning a Homecoming for February of 1991.

ICCTA representative Groharing reported that a search was being conducted for a new ICCB Executive Director to replace Dave Pierce; that the recent Annual Convention went very well; and that the next meeting would be held on September 7 and 8.

Foundation Liaison Yemm reported that Bob Farrell had presented the Foundation a draft of a five year "Case" for the Resource Development Committee to review, revise, and implement.

Chair Simpson had no report.

Contract:

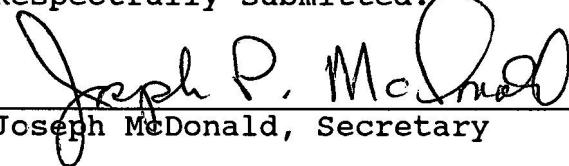

MEMORANDUM

To: SVCC Board of Trustees Date: June 14, 1990

Environment

As you will recall, Chair Simpson has asked what the college is doing in the area of recycling to protect the environment. Following this direction, I have asked the administrative staff to provide me with efforts in each of their areas with respect to recycling and similar environmental concerns. I have summarized below the results of my investigation.

Paper

1. Waste paper in the Print Shop is used for press set-up purposes.
2. White paper waste is reused for the computer or in the instructional typing laboratories.
3. Scrap paper in administrative offices is either cut up for message-taking use; rough drafts, ASSET and GED testing scratch paper, and/or sent to the Print Shop to be cut and glued into scratch pads.
4. We are careful not to overstock paper supplies--particularly in the Print Shop--in order to save on paper wasted due to spoiling in storage.
5. All administrators try to minimize the numbers of Xerox copies made.
6. Newspapers and old Pathfinders are collected by our mail-room clerk for recycling. One office saves magazines and donates them periodically to churches, scouts, or similar civic organizations during their paper drives.
7. The Computer Center previously sold punched cards and used computer paper but the market for these items has virtually dried up.

8. Most administrative offices are re-using manila folders numerous times.

Aluminum Cans

Among maintenance staff members, a work-study student in the Reading Center, the Electronics Club members, and one Board of Trustees member, all aluminum cans are picked up and recycled.

Glass/Plastic

A member of the maintenance staff collects glass and plastic containers from college trash.

Scrap Metal/Wire

The maintenance staff collects/recycles any scrap metal or wire.

Oil

The automotive technology/diesel technology area recycles oil through a Wisconsin firm.

Refrigerant/Anti-freeze

A refrigerant and anti-freeze recovery/recycling system for the automotive/diesel area is in the 1990-91 budget.

Styrofoam

Use of styrofoam cups has nearly ceased at the college and we will encourage their complete disappearance.

About the only thing that is not currently being recycled is the wet garbage from the kitchen and that which is picked up in our offices/classrooms. All of this plus loose trash not recycled is compacted into bales which are approximately 2 1/2'x 3'x 5' and weigh over 300 pounds each.

Environment

Hazardous Materials

1. A one-day workshop was recently conducted on campus concerning the management of hazardous material/wastes.

2. All allied health and science programs are using recommended procedures to dispose of hazardous materials from supplies used in the laboratories.

3. In the Print Shop, all compatible chemicals are appropriately labeled and kept in one area. Furthermore, hazardous chemicals are disposed of in special containers which are given to the maintenance staff for appropriate disposition. Only approved chemicals are dumped down the Print Shop drain and then only with a three to one dilution with water. Also, Print Shop employees wear protective gloves and are informed of the proper handling procedures. MSDS chemicals information is available for reference.

Air Pollution

1. A campus smoking task force limited smoking on campus to a few areas and banned it from college vehicles. This committee will be re-convening in the Fall to consider further reductions in smoking areas.

2. We are exploring possible ventilation changes in the Print Shop.

3. Although it would be costly, we could consider replacing all chalkboards with slick boards thus reducing chalk dust pollution.

Our staff has long been concerned about the environment and is doing much about it. Our recycling and environmental protection efforts are widespread and the concern of the Board of Trustees and this report have heightened our awareness and increased our concern. We will be doing more.

404.01 Appointment of College Staff

- A) Administrative staff and instructional faculty shall be appointed by the President subject to the approval of the Board of Trustees.
- B) Classified staff shall be interviewed and recommended for appointment by their appropriate supervisors. Salary recommendations shall be reviewed by the Dean of Business Services and all classified staff appointments shall be subject to the approval of the President.
- C) All appointments shall be within prescribed budgetary provisions and in accordance with classifications, wage rates, and schedules approved by the Board of Trustees. Exceptions to the above shall require specific Board action.

405.01 Appointment of Instructional and Administrative Personnel

Normally, instructional and administrative personnel shall initially be appointed for no longer than one year. Such appointments must be reviewed annually.

Eligibility for tenure for instructional faculty is based upon completion of three years of full-time professional service at SVCC. Administrators are not eligible for tenure.

Notice of Non-reappointment

For instructional faculty not on tenure, if the employee is not to be re-employed at the end of the employee's contract, the employee shall be given written notice no later than March 1 of the contract year. Non-reappointment of administrative personnel is as defined in the policy pertaining to contract continuation for administrative personnel.

405.02 Oral English Proficiency Policy

The Sauk Valley Community College Board of Trustees recognizes that the ability to communicate effectively is an essential skill necessary for faculty. Therefore, to assure that all SVCC faculty are proficient in oral English, it is the policy of the Board of Trustees that the following guidelines be used in the evaluation of candidates for employment for teaching at the college:

Full-time Faculty

Effective July 1, 1987, all final candidates for full-time employment, in any position where a classroom teaching assignment may be a required component of the position applied for, will be required to make a fifteen minute, oral lesson presentation which will be evaluated for oral English proficiency by appropriate college administrators.

Part-time Faculty

Effective July 1, 1987, all new personnel hired for part-time teaching assignments at the college will be required to attend screening interviews with the appropriate instructional dean or his/her designated representative, such interviews being structured to insure appropriate evaluation of oral English proficiency.

All supervisor evaluations of current teaching faculty will include an assessment of oral English proficiency, and all positive recommendations made pursuant to such evaluations will be indicative of a satisfactory evaluation of oral English proficiency.

In the event of a negative recommendation related to oral English proficiency made pursuant to an evaluation of a current teaching faculty member, SVCC will favorably consider reasonable requests for Faculty Development fund resources to pay for such special assistance as may be necessary to improve the spoken English competency to an acceptable proficiency.

Bids for new X-Ray Laboratory equipment were advertised in May and three bids were received. The low bid was submitted by L & L X-Ray Service, Inc., of Schaumburg in the amount of \$59,258. This project was submitted to the Sauk Valley Community College Foundation and in February of this year they passed a resolution to pay an amount equal to two-thirds of the cost or \$25,000, whichever was less.

We are also recommending that the balance of the cost for this equipment be made a part of the operating budget for fiscal year 1990 rather than be deferred into the next fiscal year.

PREVAILING WAGES RESOLUTION

According to Illinois law, it is necessary that a resolution establishing prevailing wages be adopted by each school district during the month of June. Subsequent thereto, the college must publish a notice of establishment of prevailing wages in the local newspaper. A certified copy of the adopted resolution establishing prevailing wages must be forwarded to the Secretary of State in Springfield.

RESOLUTION

ESTABLISHING PREVAILING WAGES

WHEREAS, Illinois Revised Statutes, Chapter 48, Section through 39S-12, Prevailing Wage Law, as amended, requires that the public body awarding any contract for construction of public works, exclusive of maintenance work, shall ascertain the general prevailing hourly rate of wages for employees engaged in such work; and

WHEREAS, the statutes further provide that said rate of pay be publicly posted and/or kept available for inspection by any interested party and certified copy thereof promptly filed in the Office of the Secretary of State;

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Sauk Valley Community College, Lee County, Illinois, to the extent as required by "AN ACT regulating wages of laborers, mechanics, and other workmen employed in any public works by the State, County, City, or by any public body or political subdivision or by anyone under contract public works," as amended, the general prevailing rate of wages in the locality for laborers, mechanics and other workmen engaged in the construction of public works coming under the jurisdiction of the Board of Trustees is hereby ascertained to be the same as the prevailing rate of wage for construction work in Lee County area as determined by the Department of Labor of the State of Illinois as of June 1, 1990;

BE IT FURTHER RESOLVED that nothing herein contained shall be construed to apply to the prevailing hourly rate of wages in the locality for employment other than public works construction as defined in the ACT; and

BE IT FURTHER RESOLVED that the Secretary to the Board of Trustees be and is hereby directed to file a certified copy of this Resolution with the Secretary of State and the Department of Labor of the State of Illinois;

BE IT FURTHER RESOLVED that the Notice of this determination shall be published in the Dixon Telegraph in the City of Dixon, Illinois, a newspaper of general circulation within the area;

BE IT FURTHER RESOLVED that the Secretary shall publicly post or keep available for inspection by any interested party in the main office of the Board of Trustees this determination of such prevailing rate of wages; and

BE IT FURTHER RESOLVED that the Secretary to the Board of Trustees shall mail a copy of this determination to any employer and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workmen whose wages will be affected by such rates.

Generally any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration such as the day after Thanksgiving for Veterans Day. If in doubt, please check with IDOL.

Explosives and/or fission Material Trucks; Mixer Trucks 7 yards or over; Mobile Cranes while in transit; Oil Distributors, 1-man operation; Pole Trailer, over 40 feet; Pole and Expandable Trailers hauling material over 50 feet long; additional 50¢ per hour; Slurry Trucks, 1-man operation; Winch Trucks, 3 axles or more; Mechanic - Truck Welder and Truck Painter.

Class 4. Asphalt Plant Operators in areas where it has been past practice Dual-purpose vehicles, such as mounted crane trucks with hoist and accessories; foreman; Master Mechanic; self-loading equipment like P.B. and trucks with scoops on the front.
