### **Presentation:**

In the College's health clinical areas, the use of simulators assists students due to the limited clinical experiences available to them. Simulators mimic high-stress situations and force students to utilize critical thinking skills.

The Nursing Department is continuing to grow its inventory of simulators and respond to industry needs by replacing the outdated SimMan with a Nursing Anne simulator, equipment, and accessories. The Nursing Anne simulator provides added flexibility, allowing a more realistic patient experience than the SimMan simulator. The College recently was awarded approximately \$387,000 in state funding through the Pipeline for the Advancement of the Healthcare Workforce Program (PATH) to assist in funding needs. In order to be compatible with the previously purchased equipment, these items must be purchased from Laerdal Medical Corporation. The Sole Supplier letter is attached.
