Presentation:

The College has used Baker Group to update and troubleshoot its Building Automation System. The services include troubleshooting problems in the system, making changes in the programming, assisting with installation of updated equipment, and teaching Sauk staff related processes.

The agreement with Baker Group will have a three-year term beginning on July 1, 2023. The three-year contract amount for services totals \$39,156/\$13,052 per year, which includes 96 onsite hours per year along with 24/7 technical support.

Contracts related to interconnect equipment, software, and services are exempt from public solicited bids under the Public Community College Act (110 ICLS 805/3-27.1) and SVCC Board Policy (305.01). The contract will be funded through College unrestricted resources (the Operations & Maintenance Fund).

Recommendation:

The administration recommends the Board approve the contract with Baker Group totaling \$39,052 for a three-year term beginning on July 1, 2023, and ending on June 30, 2026.
