The Interlocal Purchasing System, better known as the TIPS Purchasing Cooperative (TIPS), is a national purchasing cooperative that offers access to competitively procured purchasing contracts to its membership. TIPS is housed at and managed by the Region 8 Education Service Center located in Pittsburg, Texas.

The administration finds it desirable to participate in TIPS to gain access to nationally competitive vendor contracts for the procurement of goods and services necessary in the operation of the College's programs and services. Specifically, the College is considering participation in TIPS contract covering the purchase install of new gymnasium bleachers.
