Presentation:

The Board approved the addition of the Diagnostic medical Sonography Program for Fall 2024 at its November 27, 2023 meeting. The Program requires specialized equipment necessary for student instruction. Pipeline for the Advancement of Healthcare Workforce (PATH Program) grant funds are available to fund allowable program start-up costs.

The invitation to bid was publicly advertised on Monday, February 14, 2024 in the Dixon Telegraph. Four (4) bids were received, opened, and read aloud at the College meeting on March 12, 2024 at 1:00PM (CST). The results were as follows:
