The administration has been in the process of hiring an English and Language Arts Faculty. The position was advertised online on Sauk Valley Community College's website, *Chronicle of Higher Education*, and HigherEdJobs.com. The College received forty-one applicants. Four candidates were invited for an on-campus interview. A committee was composed of Ruth Montino, Sarah McFarlane, and Tom Irish. Dr. Patrice Hess, Dean of Transfer Programs and Academic Support Services, served as Chair.

Academic Background: Katrina Graff received her Master's in English from the University of Texas at the Permian Basin. She is working on her Master's in School Counseling from Fort Hays State University. She received her Bachelor's in English from Olivet Nazarene University.

*Professional Background*: Katrina had been employed by Merrill Elementary School of Rock Falls, Illinois. She is employed with Ohio Community High School and has been since August of 2016.
