### **Presentation:**

In the college's health clinical areas, the use of simulators assists students due to the limited clinical experiences available to them. Simulators mimic high stress situations and force students to utilize critical thinking skills. This academic year, the College was awarded approximately \$242,000 in state funding through the Pipeline for the Advancement of the Healthcare Workforce Program (PATH). As part of the grant's budget and outcomes, the Nursing Program uses the Sim2Grow medication administration system to mimic the medication administration systems used at clinical sites. Due to the volume of students and the need to increase access, the program would like to expand its licensing and devices with Sim2Grow, which includes the purchase of 14 iPads and 6 new licenses, totaling \$45,360.


