#### **Presentation:**

The use of simulators in SVCC's health clinical areas assists students due to the limit clinical experiences available to them. Simulators mimic high stress situations and force students to utilize critical thinking skills. The College recently was awarded approximately \$488,000 in state funding through the Pipeline for the Advancement of the Healthcare Workforce Program (PATH). As part of the grant's budget and outcomes, the Nursing program is seeking to expand its simulation training. After researching several pieces of technology, the program has identified the Sim2Grow Simulations Solutions Medication Administration System. Contracts for integrated software and equipment are exempt from publicly solicited bids under the Public Community College Act (110 ILCS 805/3-27.1) and SVCC Board Policy (305.01).

#### **Recommendation:**

The administration recommends the Board approve the purchase of the Sim2Grow Simulation Solutions in the amount of \$109,473.00 to be paid from the PATH Grant funds.
