The project was publicly advertised on August 19, 2023 in the Dixon Telegraph. Two (2) bid proposals were received, opened, and read aloud at the College meeting on September 12, 2023 at 3:00 p.m. The results were as follows:

The bid package requested a Base Bid. The low bidder was Ken Nelson Auto Plaza of Dixon, Illinois with a base bid amount of \$50,405. The low bidder was interviewed by phone, and the equipment and delivery timeframe were confirmed. This vendor has the experience, capability, forces, and equipment per the requirements of the bid. Restricted Use Funding Bond Proceeds is the funding source
