2025 AMENDMENT TO ARTICULATION AGREEMENT

This 2025 Amendment to Articulation Affiliation Agreement ("2025 Amendment") amends the Articulation Affiliation Agreement dated effective January 1, 2025, as may be subsequently amended (collectively, the "Agreement") by and between Trinity College of Nursing & Health Science ("School") and Sauk Valley Community College ("Organization") (each a "Party," and collectively the "Parties").

WHEREAS, the Parties entered in an Articulation Agreement dated October 6, 2023, as may be subsequently amended, wherein the Parties agree to collaborate in the development and implementation of an unpaid internship experience for Students; and

WHEREAS, the Parties now wish to amend the Agreement as more particularly described herein;

NOW, THEREFORE, in consideration of the mutual covenants and agreements, and subject to the conditions and limitations set forth in the Agreement and this 2025 Amendment, the Parties hereby agree as follows:

- 1. **Addendum A**, attached hereto and incorporated by reference herein.
- 2. This 2025 Amendment shall be effective as of the date this 2025 Amendment is fully executed by the Parties (the "2025 Amendment Effective Date").
- 3. Capitalized terms not defined herein shall have the meaning set forth in the Agreement. Except as expressly modified by this 2025 Amendment, all other provisions of the Agreement shall remain in full force and effect. In the event that the terms of this 2025 Amendment and the Agreement are in conflict, this 2025 Amendment shall be controlling.

Addendum A

Amendment to the Trinity College of Nursing & Health Sciences and Sauk Valley Community College Articulation agreement dated October 6, 2023.

Paragraph 3 of the agreement has been amended to the following:

The Articulation Agreement is designed to provide participating students with a specific pathway to meet degree requirements established by Sauk Valley Community College for an Associate of Science degree in a health care field and a Bachelor of Science in Health Sciences at Trinity College of Nursing & Health Sciences.

Academic Requirements Section 2 has been struck and should read as though removed from the agreement:

Articulation Agreement

Trinity College of Nursing & Health Sciences of Rock Island, IL, and **Sauk Valley Community College** of Dixon, IL believe that a cooperative program benefits students by allowing students an opportunity to earn degrees from both institutions.

This agreement defines the Dual Degree Program Articulation Agreement between Trinity College of Nursing & Health Sciences and Sauk Valley Community College for qualified students seeking to complete their Associates degree from Sauk Valley Community College and the Bachelor of Science in Health Sciences (BSHS) curriculum at Trinity College of Nursing & Health Sciences.

Agreement

The Articulation Agreement is designed to provide participating students with a specific pathway to meet degree requirements established by Sauk Valley Community College for an Associate of Applied Science (AAS) degree in ADN or Radiologic Technology and a Bachelor of Science in Health Sciences at Trinity College of Nursing & Health Sciences.

It is agreed and understood that each institution has the right and responsibility to make changes to its curricula and enrollment standards to maintain its academic integrity and meet accreditation standards. Such changes, if any, will be communicated to the other institution as they occur through the office of each institution responsible for implementing this dual degree program.

At the request of either institution, a meeting or conference will be held to resolve any problems and monitor progress under the terms of this Articulation Agreement.

Under the terms of this agreement, neither institution is obligated to make any payments of any kind to the other institution.

Academic Requirements

- 1. The student must earn an AAS degree from a professionally accredited health sciences program
- 2. The student must provide state licensure or certification in health sciences profession
- 3. Upon acceptance into the BSHS program at Trinity College of Nursing & Health Sciences, 75 semester hours may be transferred toward the completion of the BSHS.
- 4. Students must complete the required 15 semester hours of General Education courses prior to or during the BSHS curriculum.

 For approved General Education courses refer to Appendix A.

- 5. Upon successful completion of the BSHS program at Trinity College of Nursing & Health Sciences, 30 credit hours will be awarded towards the Bachelor of Science in Health Sciences.
 - For approved BSHS credits refer to Appendix A.
- 6. Students who successfully complete the BSHS program at Trinity College of Nursing & Health Sciences will be eligible to participate in commencement.

Accreditation

Trinity College of Nursing & Health Sciences and Sauk Valley Community College will ensure that they maintain accreditation with the Higher Learning Commission regional accrediting body and ensure all operations will be in keeping with accreditation requirements of the two institutions.

Duration and Termination of Agreement

Trinity College of Nursing & Health Sciences and Sauk Valley Community College agree that this Agreement shall be in force the date of the signing of the Agreement and shall remain in force until modified or terminated in writing, following reasonable and mutual discussion by representatives of the two institutions.

Trinity College of Nursing & Health Sciences and Sauk Valley Community College reserve the right to revise or eliminate programs and courses. Such changes will be communicated to the appropriate parties. This articulation agreement will be reviewed annually to ensure currency with each party's degree requirements and may be modified by attachment.
